Minutes of Annual Meeting-2009  
January 31<sup>st</sup> 2010

The meeting opened at 12:15pm with prayer led by Rev. Mike Conrad. Linda Strachan welcomed everyone to the meeting.

-It was moved by Wendy and seconded by Gordon Hamlin that Linda Strachan chair the meeting and Nicole Chenell act as secretary for the meeting of January 31<sup>st</sup> 2010. Motion Carried.

-It was moved by Gordon Hamlin and seconded by Rick Morash that the minutes from the annual meeting of January 25<sup>th</sup> 2009 be accepted as circulated. Motion Carried.

Business Arising from the minutes: Gordon Hamlin requested information on St. Luke's. Doug Gillett gave a report on the progress, at one point there had been a possible sale however the purchasers wanted it zoned for R4 and this zoning is no longer possible in that area. The company handling the sale is CBR Ellis. Rev. Mike Conrad thanked Doug for all of the effort he has put into this, Doug also thanked Rev. Mike for his help.

Communications: Nicole Chenell read a letter from the Diocesan Archives Committee. Rick Morash asked if this could be included with another committee so we wouldn't have to create another committee. It was moved by Gordon Hamlin and seconded by Rick Morash, that the Heritage Committee request form the Archives be taken to council to see if another committee is needed. Motion Carried.

Presentation of Insurance Policies: Keith Fraser gave a description of the budget worksheet. Insurance still remains on St. Luke's, \$75,000.00 is the minimum required.

New Business: It was moved by Marilyn Hamlin and seconded by Jinny Giza that the reports be accepted as circulated with the following changes: Spiritual Development Report and 90<sup>th</sup> Anniversary Celebration Committee Report, the guest speaker should read Rev. Reg. Macdonald, previously reported as Rev. Glen Kent, and on the Nominating committee report the contact person for PWRDF should be Marilyn Hamlin and Spiritual

Development contact person should read Rev. Judie Lafford. On the Outreach Report it should read \$583.00 was raised for White Gift Sunday not \$300.00. Motion Carried.

Rectors Report: As circulated. Rev. Mike reported that Jean Schwartz and Sharon Polkinghorn had been members of the Spiritual Development committee and Choir for several years and we need to acknowledge all of their years of service in both ministries.

NSOM Report: As circulated. Doug Gillett commented that Rev. Judie has made many calls to the young people of our church to get the involved in the services bringing them in as crucifiers, candle bearers and readers. Rev. Judie also stated that this has been a joint effort with Rev. Mike.

Wardens Report: As circulated. Linda stated that this has been a very busy year with the 90<sup>th</sup> Anniversary celebrations. The key situation is going very well, for insurance purposes it was needed to know where the keys for the church were at all times. Linda commented on the work done by the property committee.

Ladies Group Report: Sharon wanted to thank Jim Polkinghorn for all of his help during her time as president of the ladies group. Sharon also commented that she and Jean Schwartz organized a Variety Show that was held on March 15<sup>th</sup> 2009 for the 90<sup>th</sup> Anniversary and this was omitted from the 90th Anniversary Report.

Outreach Report: Renee Fraser was very happy with the 50<sup>th</sup> Anniversary of the PWRDF and thanked Rev. Mike for supplying the Miners hats for the service. Thanks to everyone for all the support from Renee and all of the committee members.

Pastoral Care Report: Connie reported that the committee is trying to find ways to reach shut ins if anyone knows of any persons who would like a visit. Linda thanked the committee for all of their hard work.

Soup Kitchen Report: Lloyd thanked Tom Richardson for his contributions to this committee. He stated that they had to turn people away for serving as they had so many people volunteer to serve. Keith asked

if we could increase our \$240.00 a year donation. It was moved by Marilyn and seconded by Emily Rhyno that we will now donate \$500.00 a year to the soup kitchen. Motion Carried.

Budget for 2010: Doug explained how the budget is calculated every year. The diocese sets stipend benefit. Housing allowance last year was \$1200.00 and for 2010 it is now \$1400.00, Doug also went over the housing allowance policy. Linda thanked Doug. Paul Dort questioned the snow removal budget, it was explained that last year we hired a new company as Brad Oxner was no longer able to do this and the new company was quite expensive. It was also explained that this year we have hired another new snowplow operator and the charge is \$50.00 per hour. Rev. Mike added that we have spent almost \$37,000.00 on renovations this year without having to borrow and he is very optimistic on where we are going for 2010.

Election of Warden: Lloyd Miller nominated Renee Fraser as Warden for 2010 & 2011, seconded by Rick Morash. Motion Carried.

It was moved by Keith Fraser and seconded by Doug Gillett that the whole nominating committee report for all positions, committees and groups be accepted as shown on reports as amended. Motion Carried.

Linda thanked Wendy Wells for taking over the member at large position for Bob Angus. She also thanked Marilyn Hamlin, Rick Morash and Tom Richardson for their service on council. It was a pleasure to work with everyone and Linda welcomed Lloyd as the chair warden for 2010. Rev, Mike thanked Linda for all of her hard work at our church. On behalf of the parish Lloyd thanked Linda and the new members of council. Renee expressed that it is an honor to be asked to be Jr. Warden and commented that Linda has done a tremendous job.

Marilyn reminded everyone that the sign up sheets are at the back of the church if you would like to have your photos done for the photo directory.

Gordon moved adjournment at 1:50pm.

**Rectors Report**  
**to the Annual General Meeting**  
**of the Parish of Timberlea - Lakeside**  
**January 30th, 2011**

The gospel proclaimed in our church this morning was taken from the Gospel of Matthew and contained the familiar verses from chapter five, verses one to twelve. Together we call these verses the *Beatitudes* and what they proclaim is a number of ways in which we are blessed. As I prepare this report I do so mindful of the many ways we in this parish of *Timberlea-Lakeside* receive, and reflect, God's blessing.

I begin with words of thanks. To the members of **Parish Council** for their service this past year. Particularly I give thanks for the leadership of **Lloyd Miller** who completes his term as parish warden. For **Don Schwartz** and **Jinny Giza** whose term as members of parish council is now concluded. Thanks also to **Keith Fraser** as he steps down from the position of parish treasurer after years of faithful competent service to the task. It bodes well, and is a sign of the strength of our parish, that key leaders can relinquish old roles and competent individuals are at the ready to assume leadership roles of their own. I look forward to working with parish council in 2011 to continue to live out our mission statement while striving for a vision of the future that makes God's love, God's kingdom known among us and among those we meet and serve.

I give thanks for the ministry team of **Rev. Judie Lafford**, Associate Priest, **Rev. Ron Walker**, Honorary Assistant, **Marilyn Hamlin**, postulant for the diaconate, and **Wendy Wells**, Layreader. I ask your prayers also for **Doug Gillett** who is now taking part in a program of study leading to his commissioning as a Layreader. Thanks also to **Rev. David Dellapinna** and his wife **Bev** for their ministry with our confirmation class. Finally thank you to **you** the members of our congregation whose participation in the life of our Church gives witness to the presence of the Risen Lord in us and among us.

Looking back there were a number of highlights in 2010. Back on March 21st some eighty people turned out for a meal together followed by a service of *Evensong* during which Marilyn and Gordon Hamlin presented a slide show presentation of their trip to the Middle East. September 19th was *Back to Church Sunday*, and this event was marked by a *'full house'* who enjoyed a day of worship, a meal and activities together. As a result of that service we have been fortunate to welcome new members to our parish family. On September 30th St. Andrew's welcomed *Threshold Ministries* (formerly the Church Army) to a worship service with the opportunity to hear about the work of Threshold Ministries and the Church Army around the world. Thank you to **Rev. Ron**, who was commissioned as an officer in the Church Army forty-six years ago, for organizing this event. The year also ended on a highlight. This is the second year that we have held three services at St. Andrew's on Christmas Eve. It was most satisfying to see all three services well attended.



I continue to give thanks for the ministry of our Sunday School Teachers. **Heather, Nicole, Jo-Anne and Kim** are doing a wonderful job with our young people. The number of children in Sunday School and their attendance rate speaks of the success of the program. Thanks also to **Nancy** who helps prepare the children for their occasional gift of music to the congregation.

I also want to speak to the work of the **Property Committee**. Improvements continue to be made to our facility through the conscious efforts of **Jamie Wile**, property committee chair, and the committee members. Major projects this year included the installation of a new sign for our church, the construction of an office for the rector and the installation of emergency lighting. These additions have improved both the function and visibility of our church. I am encouraged by the plans for 2011 which include renovations to the **Fellowship/Choir Room** as well as other renovations to the interior of our church to bring it in line with requirements from the Fire Marshall while improving the general appearance of our building.

Another matter pertaining to property is the potential sale of the St. Luke's property. A tentative deal is now in place contingent upon the purchaser being able to have the property rezoned. This is likely to be a lengthy process (six or eight months?) but we are hopeful of the eventual approval and sale. We give thanks to **Doug Gillett** for his leadership in moving this project forward.

While we look back at the accomplishments of 2010 with a sense of satisfaction, we can look forward to the possibilities of 2011 with optimism. Started in 2010 but concluding in 2011 is our confirmation class. On March 6th Bishop Moxely will be with us to lay hands on *sixteen* individuals for the sacrament of Holy Confirmation. We look forward to this celebration with the bishop, the candidates and their families as they are strengthened and empowered by the Holy Spirit for service in Christ's Church.

A *Parish Mission* is planned for the fourth Saturday in Lent, April 2nd. Rev. Ron is taking the lead in organizing this event with a group from St. George's Anglican Church in New Glasgow. This will present the parish with a wonderful opportunity to gather in the Lenten season for a time of renewal and fellowship.

Because of the success of *Back to Church Sunday* it will in all likelihood be repeated this year. I look forward to building on the success we enjoyed last year but challenge both myself and the congregation to make every Sunday *Back to Church Sunday* by taking the opportunity to tell others of why our church is important to us, and inviting them to become part of the family.

Last year we worked to put together a **Mission Statement** and a **Vision** for our parish. We have developed an action plan to facilitate our achieving who we say we are, who we want to become. I look forward to 2011 as a year when the tiny steps we have taken, lengthen into bold long strides towards the objectives we have set at becoming a *Caring, Welcoming, Friendly* congregation reflecting God's Love.

## POSTULANT'S REPORT – 2010 Annual Meeting – St. Andrews Church

On June 24, 2010 Suffragan Bishop, Ronald Cutler informed me that I had been “Accepted as a postulant for ordination for Non-Stipendiary Ordained Ministry” in the Diocese of N.S. & P.E.I. To be more specific, I am called to the ministry of servanthood as a Vocational Deacon. Information on this ministry may be found on page 655 of the Book of Alternative Services.

I am presently in my fourth and final year of a theological education program called Education for Ministry (EFM). It includes attending a class once a week, with additional reading, research and study at home.

Six weekends a year I meet with the deacons of this diocese for study, for clergy-led workshops, hands-on activities, retreats and formation. This is an education program designed especially for deacons and continues following ordination. It is my responsibility to keep a Log Book during my time as a Postulant and it is updated regularly by me and by Rev. Mike.

Bible Study, Book Studies and Prayer time are part of my personal Rule of Life. Attending Clericus, ordinations, meeting with clergy on a regular basis and spending time with a Spiritual Director help keep my life Christ-centered.

My ministry here at St. Andrew's gives me great joy as I assist the clergy in areas of public worship, in planning and preparation and in connecting with members of our parish family. Through visits to hospitals, homes and nursing establishments, I help provide pastoral care. I accompany Rev. Mike and Rev. Judie in taking communion to shut-ins. Being a member of the Ministry Team and part of the Spiritual Development, Pastoral Care and Outreach Committees provide opportunities for collegiality and proclaiming the Word of God.

In the area of outreach, I am the PWRDF representative for St. Andrew's Church. I'm also a member of the St. Thomas Church Team which meets with an offender from Springhill Penitentiary in hopes of establishing a Christian-based relationship to aid his reintegration into society. As a liaison between St. Andrew's Church and the Beechville, Lakeside, Timberlea School, my hope is to help develop a supportive relationship which may be able to accommodate needs that might arise at the school.

I have much to be thankful for. I am thankful that at this time in my life God has seen fit to call me to this ministry of servanthood. I am thankful for the love and support of my family. I also give thanks for the guidance and encouragement from Rev. Mike, Rev. Judie and Rev. Ron and the confidence they have in me. Finally, I am grateful for the congregation here at St. Andrew's...a congregation of all ages. Your smiles, your words and your actions are examples of a caring, welcoming and friendly parish family...a family which surrounds me with love and support on my journey.

## Property Report for 2010

The year started off with a Fire Safety Inspection of the St. Andrews Church. A report was issued with numerous items that required immediate attention. After consultation with the inspector, a priority list was established. New handrails were installed in the hall on the side of the stairs that lead to the stage area. We installed emergency lighting and emergency exit signs at all exit points. Emergency evacuation route plans in picture frames were installed at the exits too. Finally, a door closure on the furnace room entrance was installed.

One other major point in the report was having fire rated wall coverings in ALL rooms of the church. We started with phase one of the fire rated drywall installation with the new rector's office.

We took the opportunity this year, to finally provide Rev Mike with a proper office, while complying with the fire inspectors request to 'fire rate' the wall covering in the lady's, old choir room. The new office has fire rated gypsum drywall, replacing the old particle board paneling. When construction began, we also added a new venting window to the office.

Later this current year, 2011, we plan to tackle the men's choir room and bell tower area with new drywall to comply with the fire inspectors report.

Spring time finally came and we had our annual spring yard clean up. Thank you to all those helping hands to perform this yearly task on the Saturday morning of the church yard sale. Mark your calendar this year again too, eh?

Shortly after the yard cleanup, came the new roadside sign installation. A new 8 foot tall x 4-1/2 foot wide, double sided, lighted sign was installed. Later in the year, we had the wheelchair ramp professionally painted.

I wish to thank all those persons and companies who helped out with the many, many projects that we accomplished this past year. I look forward to the new projects planned (fellowship room + new choir room closet and bell tower drywall), and to the other un-planned projects, that will come in 2011.

The Fort Sackville Regional Council met twice during the year 2010.

At our meeting in February, 2010, we had guest speakers on Puppet Ministry and Refugee Sponsorship. Catherine Tutton showed us the puppets she has made and the ones she will teach the children to make. She has decided to take her workshops to the churches as the workshops she had been holding at Trinity in Halifax had not brought out enough children and youth.

Ray Carter from the Diocesan Refugee Committee spoke to us on Refugee Sponsorship. He gave us information on how to get started in sponsoring a family, the costs and the different types of sponsorship we could have.

At this meeting Rev Tammy Hodge gave us an update on our pilgrimage to Annapolis Royal. We also had reports from the Anglican Church Women and Diocesan Council. We made a motion to donate \$100 for bread and wine for the 300<sup>th</sup> Anniversary Service in memory of our previous Regional Council Treasurer, Janet Benight.

In October, 2010, we met and discussed Refugee Sponsorship, Behavioral Covenants, and listened to reports from the ACW, Diocesan Council and talked about a letter from Bishop Sue on same sex marriages.

In regards to Refugee Sponsorship we discussed different ways of helping out. There are three or four different groups in our diocese sponsoring refugee families. Some parishes are donating supplies or money to the Diocesan Refugee Committee as a way of helping. We touched briefly on the topic of Behavioral Covenants and decided that more information would be brought to the next meeting.

We learned from the Diocesan Council Report that Bishop Sue will be on a Sabbatical at the beginning of 2012 for 3 months. She is going to be studying liturgical movement and dance. Bishop Sue hopes that the diocesan allotment can be reduced and this was discussed in length.

A motion was made at this meeting to donate the \$2000 our region was given for our pilgrimage to Annapolis Royal, to St. James Church, Armdale to help them with their refugee family. We shared some of our experiences with Back to Church Sunday and how positive this had been in our churches. We agreed that the letter on same sex marriages should be discussed at Parish Councils and each parish should send their recommendations to the Bishop

PRIMATES WORLD RELIEF & DEVELOPMENT FUND  
Report for 2010

In 2010 two natural disasters prompted emergency response from the PWRDF.

The first was on January 12 when a devastating earthquake struck Haiti. Thousands of lives were lost and there was major damage to the infrastructure of that country.

Not too long afterward, Pakistan suffered massive flooding and again lives were lost and homes destroyed.

The PWRDF stepped in immediately with emergency relief in both these disasters and through the ACTION by CHURCHES TOGETHER (ACT) ALLIANCE committed funds for the disbursement of clean water, food and other survival goods.

The government of Canada matched donations made by individuals and groups across the country. Members of St. Andrew's Church generously donated to both these disasters in the amount of \$1,899.50. An additional donation of \$200.00 was made by the parish to the Haitian Relief Fund.

The PWRDF is the Anglican Church of Canada's agency for development, relief, refugees, and global justice. An example of one of its projects is a Public Health Program in Mozambique to which it is committed for three years. The project is called "THE MOTHERS' IN WAITING HOUSES". Pregnant women are advised by their community health workers to move into the houses a few days before their delivery date. The houses are clean and well-equipped. Mothers can deliver their babies in a supportive environment with medical staff available. The lives of many mothers and babies have been saved since this program has been implemented.

At the back of St. Andrew's Church information about PWRDF is available. Bookmarks, donation envelopes and memorial cards are provided for those who wish to make use of them.

In 2010 members of this parish contributed \$1,047.38 to the PWRDF through regular weekly giving.

The total amount given to the Primate's Fund by St. Andrew's Church amounted to \$3,146.88.

As your PWRDF representative at this time, I thank you for your continued support.
