## MINUTES FOR THE ANNUAL GENERAL MEETING

SUNDAY, FEBRUARY 9, 2014

1. Opening Prayer lead by Rev. Judie Lafford at 11:50 am.
2. **Election of chair**-Rev Judie Lafford moved and Gordon Hamlin seconded that Jean Schwartz chair the meeting. Motion carried.
3. **Election of meeting Secretary**-Gordon Hamlin moved and Keith Fraser seconded that Wendy Wells be meeting secretary. Motioned carried.
4. **Corrections and approval of 2014 AGM minutes**-It was moved by Rick Orlando and seconded by Myril Wells that the minutes from last years meeting be approved as written. Motion carried.
5. **Unfinished business from previous AGM** -There is an offer on the table of \$200,000 for St. Luke's. Two brothers want to purchase it, tear it down and build a day care center. The closing was amended to March 17<sup>th</sup> from the 5<sup>th</sup>. They are having problems with the city and the zoning regulations. A question was raised about the \$200,000. Was this the ceiling? There have been several counter-offers. There are papers on file for everything that has happened so far. It will be a go if they can secure the funding. Rev Ashton has been contacted about the sale as he has been using the church. Keith Fraser thanked the members of council, wardens and Doug Gillett for seeing this through. Jean Schwartz thanked Doug for all his help with this.
6. **Business arising from the Minutes**-None
7. **Communications** - Rev. Judie Lafford thanked Rev Liz Earley for being our Priest-in-Charge
8. **Presentation of Insurance Policies** -Keith Fraser felt it might be wise to do a contents inventory again at St. Andrew's as the last one was done in 2000. St. Luke's still has basic insurance with a 5 million liability.
9. **New Business**-It was moved by Ken Richardson and seconded by Rick Morash that all reports be accepted as circulated. Motion carried.
10. **The Report of the Rector**-As circulated.
11. **The Report of the NSOM**-As circulated.
12. **The Report of the Wardens**-As circulated.
13. **Reports of the various committees of the Parish**- Ways and Means: Jean Schwartz has resigned as the Ways and Means Facilitator. Finance Committee: Doug Gillett

questioned part time ministry for our Parish and how deep it was looked at. Gordon said it was looked at lightly when Rev. Mike Conrad wanted to go south but it is not off the table.

**14. Presentation of the budget for 2014** –A deficit has been forecast for 2014. We will pay stipend, benefits, etc. for only ten and a half months. Hopefully we will do as well as in 2013 and finish with a small deficit. Bernie Conrad asked why the income was budgeted for less than in previous years. PAR (Preauthorized Remittance) has decreased. Bernie asked how we could present a budget with a deficit. The budget was created from the Income and Expenses up until October. Envelope income seems to be decreasing. Bernie Conrad suggested the budget be prepared a little later as the offering for Christmas was greater than expected and money from two fund raisers were not included in the making of the budget. It was moved by Gordon Hamlin and seconded by Rick Orlando that the budget be accepted as presented. Motion carried.

**15. Election of Junior Warden** –Linda Strachan nominated Rick Morash for the position of Junior Warden. There were no other nominations. Rick Morash was acclaimed.

**16. Election of the Council** – Rick Orlando and Anne Dauphinee were nominated as members-at-large for a three year term. There were no other nominations. Rick Orlando and Anne Dauphinee were acclaimed.

**17. Election of Synod Delegates** – Jinny Giza and Erica Orlando were acclaimed as Synod Delegates for 2014.

**18. Election of Parish Secretary**- Wendy Wells was nominated and acclaimed as Parish Secretary.

**19. Election of Parish Treasurer**- Bev Higgins was nominated and acclaimed as Parish Treasurer.

**20. Election of one or more Auditors**-Doug Gillett was nominated and acclaimed as Auditor.

**21. Election of Regional Council delegates**- Jinny Giza and Erica Orlando were nominated and acclaimed as Regional Council Delegates.

**22. Election of Correspondent to Diocesan Times** – Wendy Wells was nominated for this position and acclaimed.

**23. Altar Guild** - Helen Payne has agreed to join the Altar Guild.

Jean Schwartz thanked everyone for their support and thanked those who served on the Parochial Committee with her. Linda Strachan thanked Jean for all the work she has

done over the past two years. She also thanked Rev. Judie Lafford and Rev Marilyn Hamlin for all their work and thanked the Parochial Committee, all other committees and Gordon Hamlin for being the chair of the Finance Committee.

Keith moved adjournment at 12:25 p.m. The meeting closed with the Grace.

## Rector's Report 2015

It's been a busy year at St. Andrew's. I've certainly seen very dedicated and very hard working parishioners in every aspect of parish life together. We are blessed to have such a collection of committees and groups who know their jobs and how to get it done. It's been a pleasure getting to know the ins and outs of how St. Andrew's operates, and more importantly, how people take care of each other.

In that regard I want to commend the work of our pastoral care committee, whose ministry is an essential part of how we stay connected. They contact all members of the parish in cycles of ten households per week, checking in, visiting and making sure I know when a pastoral contact is needed. I've never seen an effort like that before and it truly speaks to what belonging to a parish family is all about.

It's been wonderful to see the sense of partnership and team ministry here. Linda and Rick have served the parish as wardens with outstanding dedication not only in attending every meeting and program we've had in support, but in their wisdom, proactive leadership and diplomatic principles. I can't offer great enough thanks for all they have done in 2014!

It's also been a privilege to share a team ministry with Revd Judy and Revd Marilyn. It's wonderful to have such skilled and devoted support in such vital areas as worship, pastoral care, logistics, and the experience they bring to understanding and caring for our parish, and all the efforts they make behind the scenes! I know we all continue to uphold the Revd Judy in her recovery, and miss her presence very much.

One of the areas of focus this year has been on family, youth and Sunday School. Overall, our hope is to create a much stronger connection with the life of the parish. We did a lot together in this regard. Sunday school became part of every Sunday service again, through weekly children's talks, presenting their special projects, developing a monthly service lead by youth with prayers created specially for younger minds. Servers training and confirmation classes have begun. We were blessed by the inspiring gifts of Devotion in Motion, our new liturgical dance troupe, who are sharing that wonderful and rare gift of bringing the Gospel to life in dance.

There were other important changes as we engaged this ministry. We moved the Christmas Pageant to the Sunday before Christmas, and also created a new kind of Christmas Eve family service. The Sunday school has enjoyed the gifts of new teachers and assistants and has taken on an excellent curriculum, The Whole People of God. Many, many thanks to our Sunday school teachers and assistants!!

There have been many people devoted to making it happen and creating other special events like the Children's Christmas Shopping day, the Halloween potluck, and general participation in fun things that build family spirit, like coming in costume Halloween Sunday, the ongoing Crane project, several Lego projects, and so on.

The work of the Spiritual Development Committee was key in our ministry to families and young people, but also in our ongoing efforts to create an atmosphere in St. Andrews that is meant to reach out in a warm and welcoming way to the wider community. We had more special services than I can recall!

A great deal of discussion has been happening with Parish Council, the wardens, our ministry team and others as to how we can create that inviting, user friendly, vibrant and life giving spirit that is as nourishing and strengthening for our devoted members, as it is for each new person who walks through our doors. I think the variety of traditional and new celebrations, and the awareness raising we've all been doing in regard to our deep sense of wanting to connect more with our surrounding community, have helped us a great deal.

Communications has also been important to our development. Some ways we are striving to communicate better, have been seen in the newsletter, bulletin refinement, a parish email list, new concern and interest in how we create a presence via the website, facebook and community links, and working hard at dialogue within our various groups as we seek to renew our parish life together.

Perhaps one of the most fundamental insights we have faced this year is our financial situation. It has been

developing for years, culminating in the forecast of a deficit of twenty thousand in 2015. We've been blessed with a highly skilled treasurer and finance committee who have thoroughly disseminated the information we've needed to get a clear picture of this, and in very early 2015 a "think tank" committee will begin looking at any and all options in addressing this extremely important issue. I have seen what this parish is capable of, and have a lot of hope for our ability to strengthen our financial position, so that St. Andrew's parish can continue in her ministry to our community in years to come. All our committees and council have worked hard at fundraising this year, and we hope to find new ways to do so in 2015.

I'm looking forward to 2015! It promises to be a very interesting year with many things to celebrate! Imagination, creativity and faith will be our inspiration, compassion and love our purpose, and God our Guide in this amazing journey we are taking together as a parish family.



It is enjoyable to be part of Regional Events including Clericus, Regional Council, Deacons' Educational Weekends, Clergy Conferences, Ordinations, A.C.W. evenings and other services in the Diocese. This past summer a highlight was our Canadian Deacons Conference which was held in Halifax. I am one of the facilitators for the Diocesan Vocations (Discernment) Weekend, a regular contributor to the Deacons' page of the Diocesan Times, and an Associate of the Sisters of St. John the Divine.

## FINANCE COMMITTEE ANNUAL REPORT 2014

The committee of 2014 was comprised of Rev Mark Pretty, Warden Linda Strachan, Warden Rick Morash, Treasurer Bev Higgins, Past Finance Chair Gordon Hamlin, Property Committee Chair Keith Fraser and me as Chair.

Meetings were held quarterly in March, June, September and November, to align with budget reporting and were scheduled for the 3<sup>rd</sup> Tuesday prior to the council meetings in each of these four months. Bulletin entries, to report the budget status to parishioners, were also promulgated quarterly at the end of the months of June, September, December and March (2015).

The committee functioned in accordance with the Terms of Reference (TOR) for the finance committee (available separately). The priority for the committee is to prepare and monitor the parish budget and to make recommendations to council regarding revenues and expenditures. Almost any parish activity or resource that involves money comes to the attention of the committee for discussion.

Following are some of the items that were addressed in 2014:

- A small revision was made to the TOR.
- The sale of St Luke's and the recommendation to council (subsequently approved) to invest and protect the principal net sum which was \$188,702.20.
- The organist contract was revised and updated.
- The copier contract was replaced and a new machine acquired.
- More oversight for the Sunday School program and its expenditures.
- Fundraising ideas to take to council.
- Confirmed that we are operating within the diocesan guidelines for mileage expense claims for the clergy.
- Reinforced our investment policy with the bank concerning the roll-over of our GICs.
- Clarified that the parish budgeting approach to the larger church renovation projects (managed by the property committee) will be to consider expenditures for projects as "budget neutral". Although the projects will show in the budget as expenditures, the money required will be fundraised and shown in the revenue column. Therefore, the goal will be to offset the project costs with an identical fundraised amount. Any surplus funds raised will be put in general revenue.

Of particular concern to the committee are the recurring annual deficit positions. We continue to spend more than we earn. Consequently the principal in our parish investments is slowly diminishing, as we

use our investment capital to cover the annual deficits. The committee struggles to find a way to balance budgets. Increased fundraising will help, but ultimately fundraising alone will not solve the problem. There is a need to increase the numbers in our congregation and to significantly increase giving. This remains a priority and a key challenge for the committee, council and the parish.

ST. ANDREW'S LADIES GROUP  
ANNUAL REPORT FOR 2014

There are seventeen dedicated ladies in St. Andrew's Ladies Group. We have 16 regular members and one Honorary Life Member.

Our executive for the year of 2014 was as follows: Wendy Wells, President; Anne Fraser, Vice-President and Secretary; Linda Strachan, Treasurer; Sandra Cowie and Helen Payne, Phone Committee.

Our year consisted of speakers, a fun night, yard sales, outreach and receptions. We continue to support our church and contributed \$1600 this year to the general fund. We raise money by holding two yard sales per year, one in the spring and one in the fall. This year our yard sales netted a total profit of \$1089.20; we raised \$628.10 in the spring and \$461.10 in the fall. We also do receptions for funerals which raise some funds as well and we sell church calendars which nets a small amount of money.

We do outreach by supporting the Marguerite Center and the Mission to Seafarers. Once a year we do up a basket of goodies containing personal care items and deliver this to them. They are always grateful for our help. In December we give them a cheque for \$100 to help them with incidentals. Our support for the Mission to Seafarers is in the form of shoeboxes which we fill with personal care items, warm hats, mitts, scarves, socks, etc. This wouldn't be possible without the generous help of the congregation of St. Andrew's. We are usually able to provide up to 60 boxes each year.

We had a Fun Night at our February meeting at which time we set aside all the work and had some fun playing old-fashioned board games. We had an assortment of games as everyone brought their favourite game and we had lots of yummy snacks throughout the evening.

We had speakers at our March, April and November meetings. In March, Dr Monique Conrad, spoke to us about strokes and the many signs we should recognize. In April, Joan Foren, spoke to us about osteoporosis and in November, Cara did a power point presentation on Alzheimer's. This was very well attended with members of the congregation joining us. We took up a free will collection which netted just under \$100 and this was presented at the end of the evening to the Alzheimer's' Society.

We provided a lunch for the World Day of Prayer service in March, as this was held in our church. We also did a special lunch in February to welcome our new rector, Rev. Mark Pretty. We held a Bake Sale in November after the two morning services, which raised \$220 for the church.

We were able to purchase two new garbage cans for the church hall this year and we donated \$50 towards the purchase of turkeys for the church supper. We gave the church a thorough cleaning before Easter.

We held our 2<sup>nd</sup> Annual Christmas Tree Lighting and Carol Sing in December. This was very well attended and we served cookies and hot chocolate in the hall with candy canes for the children.

We decorated the church earlier than usual this past year. The decorations were put up on the Saturday before the last Sunday of Advent so it would be decorated for the Sunday School Pageant. Thanks to all those who came out to help us.

We lost a good friend in the fall, Rev. Ronald Walker. He will be missed by all. We donated \$100 in his memory towards a memorial plaque which is hanging in the church.

All in all we had a pretty busy year but we had a lot of fun and fellowship working together as a group. My thanks to all of you in the group for your support and especially the support I received from you while I recuperated from surgery this year. There is no greater group of ladies than what we have here at St. Andrew's.

# St. Andrew's Anglican Church Property Committee Report 2014

Committee Members: Keith Fraser – Chairperson, Ken Richardson - Vice Chairperson, Rick Morash – Council Representative, Jamie Wile, Tim Edwards & Ian Rector

Due to financial constraints, no major projects were undertaken in 2014. However, the following smaller projects were completed:

- 1) The leak in the bell tower was fixed, screening replaced and the water-damaged ceiling was repaired.
- 2) An epoxy coating was put on the front steps, greatly improving the appearance.
- 3) The fence along the edge of the cemetery was replaced.
- 4) A number of dead trees were removed from the cemetery and the edge of the parking lot.

In addition, normal maintenance continued.

- 1) Weekly hall cleaning was carried out thanks to the efforts of Ken Richardson, Jamie Wile, Tim Edwards and Sharron, Jeff and Richard Hayden.
- 2) A very successful spring cleanup of the property was held in April with over 20 people participating.
- 3) The grass was mowed on a regular basis. Thanks to the Dellapinna family for their assistance.
- 4) Gordon Hamlin painted the exterior basement door and maintained the exterior sign. An electrical problem was repaired by Ken Richardson.
- 5) The parking lot was resurfaced with three loads of gravel donated by Conrad Brothers Limited and a backhoe donated by Ocean Contractors Limited.
- 6) Ken Richardson replaced the CO2 detector in the basement in June. It came with a 10 year warranty.
- 7) Rick Morash put up signs around the church, reminding people to turn down the thermostats to 10° when they leave. He also placed signs to indicate how tables and chairs are to be stacked in the hall.
- 8) Tim Edwards and Ken Richardson looked after cemetery lot sales, grave openings, closings and placement of markers. A number of headstones were straightened in the fall with the help of Tim Edwards and Gordon Hamlin.
- 9) The annual furnace maintenance was completed.
- 10) In the fall, a plumbing emergency was taken care of.
- 11) Ken Richardson saw to the snow clearing and salting/sanding of the parking lot by Brian Lynch. Snow was also cleared from the steps and ramp.
- 12) A decision was made to sell the two lawn mowers as they are not being used. Ian Rector is taking care of the sale.

Plans for 2015 include:

- 1) Replacement of the oil tank and two flues from the furnaces to the chimney - estimated cost - \$3,000.
- 2) The completion of the recommendations made by the Fire Marshall a number of years ago. This entails replacing the wall paneling and ceiling tiles in the stairwell area with gyproc. Because of the proposal for a wheelchair- accessible washroom on the main level of the church, some walls in the stairwell area may need to be moved to accommodate this. The estimated cost is \$8,000 (not including plumbing and washroom fixtures, to be done later) and the project would proceed once sufficient funds are raised.
- 3) We will investigate the possibility of putting the cemetery plans in digital format.
- 4) We have asked Council for guidance in dealing with waste disposal. In light of the proposed limit of one black bag, current practices must change. Currently, garbage is not sorted very well and would not pass the clear bag examination. We produce an average of 5 or 6 bags of mixed garbage every two weeks which usually is taken home and disposed of by those on hall clean-up. We will not be able to continue this practice. We are asking for help and direction from Council to resolve this problem.

I would like to thank all members of the Committee for their efforts in maintaining the property of St. Andrew's Church during the past year.

PWRDF supports a network of dioceses across Canada who help sponsor refugees to begin new lives in Canada.

When there is a crisis, whether in Canada or in other parts of the world, PWRDF, through their involvement with partner agencies familiar with the local needs, step in to provide essential services.

The Canadian Indigenous Program is facilitated through grants to community-based projects and helps to develop relationships between Canadian and overseas Indigenous communities.

Development work is supported through grants to community-based organizations that meet basic human needs, strengthen the role of women, promote peace, reconciliation and human rights, build local expertise and work to support democratic development.


Global justice education is part of PWRDF's national volunteer network.

**FORT SACKVILLE REGION ANNUAL REPORT 2104**  
**for ST. ANDREW'S CHURCH**

St. Andrew's is one of approximately 24 churches that make up Fort Sackville Region. Regional Council met four times in 2014, with 3 meetings at St. Nicholas Church in Tantallon and one at St. John's on Kearney Lake, a beautiful, new, modern church. Rev Tammy Hodge is Regional Dean and Rev. Mark Kingsbury is Regional Archdeacon.

It is an opportunity at each meeting for the various activities/events/issues from the parishes, region and Diocese to be reported and discussed. Some of the items covered in 2014 are as follows:

From Diocesan Council the Mitre's Task Force reported that information was collected and through their discernment it was decided there would be no suffragan bishop, but there has been some changes to support staff. Information on Bishop Ron's schedule is available on the diocesan website.

Financial reports are given for the Region and a report from the diocesan treasurer stated that for 2014 the financial situation has been good due to the fact that in 2013 over 94% of the parishes had met their allotments.

VSST- Vision, Strategy and Support Team-Building Healthy Parishes. Work is on-going with resource books and information available from the diocese. On this topic, an interesting presentation was given introducing an existing program from England called "7 Marks of a Healthy Church".

A Regional Lay Readers course was completed with 21 participants and a Diocesan Youth Council weekend was deemed successful.

The ACW hosted a national conference in 2014. Their efforts to raise money provided approximately \$8000.00 for an orphanage in Kenya for a widow and 8 orphans. They also ran a "white ribbon" campaign to raise awareness about violence against women.

The issue of "Safe Church" was brought up as a reminder for all parishes to have completed significant work on a plan by Dec. 31, 2014.
