## Minutes of the Annual General Meeting Sunday, February 5, 2017

- 1. Opening Prayer lead by Rev. Mark Pretty at 11:40 am.
- 2. Election of chair-Wendy Wells moved and Myril Wells seconded that Keith Fraser chair the meeting. Motion carried.
- 3. **Election of meeting Secretary**-Gordon Hamlin moved and Linda Strachan seconded that Wendy Wells be recording secretary. Motioned carried.
- 4. **Corrections and approval of 2016 AGM minutes**-It was moved by Rick Orlando and seconded by Heather Campbell that the minutes from last year's meeting be approved as written. Motion was carried.
- 5. Unfinished business from previous AGM -Nothing to report.
- 6. **Business arising from the Minutes** On page 8 in the minutes, the sentence in red is in regard to the snow clearing. Tim, Keith, and Ken have all contacted him and urged him to submit a bill. He has not submitted any yet. We have no written contract with him. It was decided to let it be. On page 6 the "\$600 bank balance difference", this was reflected in the memorial fund.
- 7. Communications None.
- 8. **Parish Asset and Liabilities** The money invested is shown on page 15. We have \$19,000 on hand at the end of the year. We have \$6000 in the Memorial Fund and \$24,000 between the bank and the amount invested with the Diocese in the Cemetery Fund. We also have the Rectory monies and St. Luke's money invested with the Diocese of which we receive quarterly interest.
- 9. **Presentation of Insurance Policies** –Insurance is found on page 17. The amount for the contents was based on the inventory taken in year 2000. We should consider updating this.
- 10. **New Business**-It was moved by Rick Morash and seconded by Ken Richardson that all reports be accepted as circulated. Motion carried.
- 11. **The Presentation of Audited Financial Statements of all Receipts and Expenditures** Bev Higgins moved and Brian Higgins seconded that the financial statements be adopted. Motion carried.

Lorraine asked what we use the Memorial Funds for. Sometimes the donations are significant and in memory of someone. We usually ask the family if we can use it to purchase something for the church. The rest is used to help with some of the projects we do. We received \$200 this year from the bottle exchange.

12. **The Report of the Rector**-Rev Mark Pretty said that our council meetings have been kept to an hour this past year. There is lots of humour at the council meetings and he finds it relaxing. The Ways and Means Committee needed someone who is a go-getter, pays attention to detail, etc., for a long time. Rev Mark felt that the coming year looked to be a lot of fun. He started giving reports to council in the fall so we would have an idea of what he does all week other than Sunday services.

- 13. **The Report of the Deacon** Rev Marilyn is keeping busy. She said her report speaks for itself. She said she enjoys this ministry she provides.
- 14. **The Report of the Wardens** The Wardens' report was written by Tim with a few changes made by Keith. Tim highlighted some of the challenges we face, especially trying to increase attendance.
- 15. **Reports of the various committees of the Parish** There has been a change in the Ladies Group. There is no President and Vice President. The group will be run with all members taking turns chairing meetings and heading events.

As Edith will be gone most of this year, the need of a Choir Director and organist to fill in was brought up. Nancy Michalko will fill in but has made it clear that she does not want to commit to the full 9 months. It anyone knows of someone who could do this, please speak to Tim. Tim has contacted the Dalhousie Music Department to see if there was any interest. He also contacted the music teacher at Sir John A MacDonald High School. Bev D suggested we might need to offer a drive. Liz suggested posting it on Social Media.

The Spiritual Development has been revitalized after a period of inactivity.

The Sunday School will start at 10:15 am. The children's talk will be downstairs. Shawn Rideout is doing a Bible study class with grades 3-5. His wife Nicole is also helping out. They have started offering tea and coffee to the parents who come early. There are 22 registered with 16 who come on a regular basis.

The Ways and Means is on page 27 and it shows the results of this committee which only started in September. Keith said a good job was done.

16. **Presentation of the budget for 2017** – It was moved by Gordon and seconded by Myril that the budget be accepted as circulated. This motion was carried.

Bernie commented on the amount of the deficit that is forecast every year. Rick O. said they err on the side of caution and plan for the worse. Bev H said there was a one-time gift of \$4500 in 2016. We had a refund on the allotment of close to \$2000. The Ways and Means raised close to \$11,000. There is \$17,000 in the difference from what was forecast and what we actually realized. It was felt that \$19,000 for a deficit was a bit large as we may have to close the doors by October. Keith said a motion was made to draw from the capital of the investments but this was not needed for 2016. Bernie questioned the increase for the envelopes. The budget is prepared in November and December's income is not included.

In the '70's we were a four point parish and money from the diocese kept us going. Fuel has gone up. Under Disbursements, the Honorarium for \$1000 was not there before. Bev H said it was included in other income. The allotment is always a year behind. We are still paying an organist and we may soon have to pay more. Bev H. said we try to be responsible and the budget is not done to scare people. Income for December was down because Christmas was on a Sunday. Keith asked Bernie to join the Finance Committee. Bernie declined.

It was moved by Gordon and seconded by Myril that the budget be adopted. Motion carried.

17. **Report of the Nominating Committee** –There is one position still open. It was moved by Rick M. and seconded by Erica that Linda Strachan be nominated for a 3 year term as a member-at-large. The chair called for more nominations and then called for the third and last time for nominations. No other nominations. Linda was elected.

The Slate of Members as listed in the Annual Report put forth by the Nominating Committee is elected.

Keith thanked the congregation for electing him as Warden and echoed Rev Mark's sentiment about the quick meetings. He also thanked Bev Higgins for her work with the Ways and Means Committee and her committee to the church. He told Tim that the Wardens are responsible for everything.

Rev. Marilyn thanked everybody and as Outreach Co-coordinator she mentioned that everyone is very busy.

Tim is the incoming Senior Warden and feels he has big shoes to full. He feels lucky that Keith lives up the road. Tim feels he is not as organized as Keith. He thanked Keith for the Wardens' list. He mentioned that we are all volunteers and said that all the committees and groups in our parish are so well run the he felt his job was easy. He will give Rev Mark and Rev Marilyn all the support they need.

Rick Morash moved adjournment at 12:25 p.m. The meeting closed with the Grace.

### 2017 Deacon's Annual Report - St. Andrews Church

As 2017 came to a close, I realized the many rewards that being a Deacon at St. Andrews had to offer. Our Ministry Team functions very well indeed and it is a joy to be part of a Parish that works so diligently in living out the Gospel. My role is liturgical, pastoral, involving both outreach work and educational moments with our Sunday School.

I continue my ministry under the direction of our Rector, the Rev.'d Mark Pretty. In the absence of Rev.'d Mark, I may lead Morning Prayer service or support our Lay Readers who are leading the service. At intervals during the year it may be necessary to provide music for a service. It is wonderful to be able to take part in our Sunday School children's story times. Providing pastoral care to those who are ill or grieving the death of a loved one is not taken lightly. It is always a privilege to assist at special services such as weddings and funerals.

Keeping track of the needs of our brothers and sisters throughout the world and encouraging our congregation to support PWRDF is one area that is a real education for me. Regular visits to BLT Schools keep us in touch with our young people in the community. I enjoy being part of the "workers" for the Ways and Means Committee.

I try to make myself available to attend Parish Council, Regional Council, Clericus, Pastoral Care and Spiritual Development Committee Meetings. Our Deacons' Community meets for regular educational sessions and I am on the Core Committee which is working on competencies for the Deaconate. This is a result of the recent Iona Report from General Synod. At various ordinations and other events at the Cathedral I have ministered as the Deacon of the Table or Deacon of the Word.

This Fall I had the opportunity to be present at an ACW event at Church of the Apostles and assisted in the Holy Eucharist. Preaching at St. George's Church last Spring was a bit daunting but enjoyable. I continue to be a member of Mothers' Union, Sisters of St. John the Divine and to write articles for publication in the Diocesan Times, and the Canadian Deacons' Newsletter. I was honoured to have been published in the Episcopal Newsletter for American Deacons' and in more localized parish material in the U.S.

I feel very blessed to be your Deacon at St. Andrews. Arriving each Sunday morning to prepare for the first morning's worship at 9:00 a.m. is a peaceful and joyful experience (accept when it is 16 degrees below 0). The light of Christ seems to shine brightly indeed. Thank you to all who make it this way.

### Finance Committee Annual Report 2017

The committee of 2017 was comprised of Rev Mark Pretty, Warden Bev Higgins, Warden Tim Edwards, Treasurer Keith Fraser, Linda Strachan and Rick Orlando as Chair.

Meetings were held on 13 June, 19 Sept and 12 Dec 2017. The March meeting was cancelled. Bulletin entries to apprise parishioners of the state of the budget were published in the latter months of 2017.

The committee functioned in accordance with the Terms of Reference (TOR) for the finance committee. The priority for the committee is to prepare and monitor the parish budget, and to monitor all revenues and expenses. Any activity that would impact revenues or expenses is discussed by the committee. The TOR was reviewed at the 19 Sept meeting and no changes were suggested.

On 14 Sept, clarification from the diocese was received for "Event Liability Insurance". This type of insurance is intended to protect the User and/or Group from actions that they may be liable for due to their negligence in connection with the renting/use of Parish owned property, subject to the terms and conditions of the policy. This suggests that any group renting our premises is required to have general liability insurance. It was agreed that the parish contract or agreement with the user should reflect this requirement. The item was taken to Council for discussion and a decision on the way forward.

Again in 2017 the parish ran a deficit. However the projected deficit for 2018 is less than that projected for 2017. There is evidence that parishioners are becoming more generous and hopefully this will continue. The tremendous efforts by the Ladies Group and Bev Higgin's Ways and Means Committee resulted in a marked improvement in revenue for 2017.

Parishioners are reminded to remain cognizant of the fact that the large majority of expenses are beyond the control of the parish. In other words, there is little or no wiggle room. For example the rector's stipend, housing allowance, the cost for fuel, electricity and insurance premiums and many other recurring expenses are all pretty much set. Similarly, the extent to which revenue can be impacted is also very limited. In essence, the only way to increase revenues without a significant incremental change in membership and giving is to continue with the parish aggressive fundraising activities. It is expected that deficit budgeting will continue to be the norm in the future for the Parish.

### 2017 Outreach Coordinator's Annual Report

St. Andrews Church continues to support many outreach programs and the members of this parish respond to the numerous needs that may arise. These needs might be in our community or anywhere in the world. We are a generous and caring people acting out the Gospel day in and day out. Thanks be to God.

During the past year, the Clergy and/or the Pastoral Care Committee contacted members of our congregation whether in their homes, hospitals, nursing care facilities, or other surroundings. When a need arose, someone responded. Communion was taken to Melville Lodge residents and to those who were home bound.

Missions to Seafarers, Phoenix House, Marguerite Centre, Bible Society, Food Banks, PWRDF and BLT Schools Breakfast Program continued to be supported during the year. In 2017 the St. Andrews "Breakfast Bucket" contributed the amount of \$1,417.95.

PWRDF received \$2,684.00 from this parish in 2017, a substantial increase over 2016. In February we hope to have a representative from PWRDF visit St. Andrews. There will be opportunity to ask questions and gain insight into the good works that our Primate's Fund does. On occasions during the year, the government of Canada matched our donations for special relief projects.

Concerts, Auction, Suppers, Luncheons, Pot Lucks, Children's Shopping day, Sunday School Pageant, Men's Breakfasts, Antique Car Display, Yard Sales, etc. all reached out to the wider community in some way. In addition to adding funds, all these events have the potential to "preach" the Good News....not necessarily by word but in how we welcome those who come into our building or onto St. Andrews property.

The Rector's Discretionary Fund supports those who may be in a financial crisis at certain times of the year. The Rector and a small advisory group are part of the decision-making process.

Remembrance Day and World Day of Prayer Service (which takes place at St. Andrews in 2018) welcomes people into our church and monies collected from special services usually are designated for projects in Canada and abroad.

Our hall and outdoor property are often available at no cost to non-profit groups. BLT may use our premises in case of emergency. Social Media, Church Web Site, Diocesan Newspaper, etc. provide information about services and events at St. Andrews. These are all ways to "Reach Out" and let others know that we are a generous and giving parish.

Our church property is still in relatively good shape. We did the usual maintenance of the property which included hall and kitchen cleaning, lawn mowing, snow clearing, spring clean-up, and cemetery care.

Committee members remained the same as last year. They are: Tim Edwards, Keith Fraser, Rick Morash, Jamie Wile, Ian Rector, and Ken Richardson as Chair.

Projects completed in 2017 included:

- 1. Modify and extend outside church ramp to meet current building code
- 2. Carry out floor repairs in church hall
- 3. Remove shrubbery from front and side of church

The church ramp improvement was a major project in 2017 and I would like to thank Tim Edwards for his input in assisting with design and looking after construction with the contractor. Many thanks also to Keith and Anne Fraser, Beverley Dellapinna, and Gordon Hamlin for painting the entire ramp.

During the winter, there was a considerable damage to the ceiling in the stairway bell tower due to melting snow. Repairs were made by Keith and Tim – they applied tar on the floor around the bell frame. We hope to repair the ceiling this year but we have to wait and see if the leaks re-occur first.

Other projects planned for 2018 include painting the small bathroom in the church hall. We are also looking at changing the lighting in the hall. Fluorescent lighting repairs can be fairly expensive with tubes and ballast replacements, so we are looking at LED type fixtures. These are long-lasting and use much less power.

Some find it difficult to hear what the Minister is saying at the pulpit – especially those up in the sanctuary. So we will be looking to see if the current loudspeaker system can be upgraded.

I would like to thank committee members and the congregation for their support through the year. The church property outside is always looking great and this is due to the untiring efforts of Keith, Anne, and Beverley. Again – thank you.

### Report on Synod May 25 to 27, 2017

This was the 147<sup>th</sup> Session of Synod for the Diocese of Nova Scotia and Prince Edward Island. The theme for this Synod was "*It's About More*".

Synod began on Thursday after lunch. The Bishop's Charge was in three parts: Part One – *Know Who You Are;* Part Two – *"Know Who You Serve"*; Part 3 – *"Know That It Matters"*. This was given over the three days.

The theme "It's About More" means that we should not be satisfied with the status quo but should broaden our horizons. Three areas of concern and hope in the church are worship, Christ formation and Mission. We want more of all these things.

There were presentations over the three days from the Innovation Group, Building Healthy Parishes, Alpha, Mission School of the Diocese, Vital Church Maritime Conference, PWRDF, AST, Growth for Ministry Fund, ACW, Youth and Family Ministry. We also had speakers from the Evangelical Lutheran Church in Canada, Maritime Conference of the United Church and the Canadian Forces.

This year is the 230<sup>th</sup> Anniversary of the Diocese of NS and PEI and it is also the 100<sup>th</sup> Anniversary of the Halifax Explosion.

Elections were held for delegates for General Synod and Provincial Synod. The elections were done a bit differently this year in the hopes new people would have a chance to get elected. Unfortunately it didn't work much better. I am the alternate for Provincial Synod only because there were 3 people nominated and they needed 2 delegates and 1 alternate.

The biggest discussion at Synod was the Marriage Canon which was brought forth and passed at General Synod last year. It has to be considered at the Diocesan Synod level and Provincial Synod before it goes back to General Synod. Once back at General Synod it will have to be passed again with a two-thirds majority. There is nothing in the Canon that prohibits same-sex marriage. The Rev Paul Friesen and Rev Paul Jennings sat as members of the commission on this canon.

Resolutions are always a big part of Synod and most are amendments to Canons. Of particular interest to us is the resolution to amend Canon 20, Regions and Regional Deans. The amendment means that at least **one**Synod delegate, between one and six additional members of the Parish (this number includes the Synod delegate), and all the licensed clergy in the region must attend Regional Council.

In Canon 35 an amendment was made to the number of Wardens a parish must have. In Parishes of 15 people or less, with the permission of the Bishop, they can elect one Warden.

Also in Canon 35 regarding Parish Government, it was moved and passed that "an annual meeting of a parish shall be held in each calendar year no later than the last day of February of that year, at a date determined by the parish council established for the parish." This is the same for Church Councils.

Canon 35, Section 20 was also amended to include the following report in the Parish Annual Report. *A report* on the parish's efforts to promote God's mission in the parish and to promote outreach.

In Canon 37 with regards to Lotteries and Raffles, the following amendment was passed. This was voted in orders. Lay -130 for and 32 against. Clergy -56 for and 16 against.

Raffles of donated items are permitted if government-required permits or licenses are obtained and the regulations are followed.

We can also raise money through entertainments such as card parties and other games which have an element of chance if the winners **do not receive a cash prize**. Lotteries and other forms of gambling are prohibited.

Any other motions you may be interested in can be found on the Diocesan Website as well as the complete Bishop's charge should you wish to read it.

The ACW divided the diocese into prayer partners. Our parish has been partnered with New London in PEI. As a parish we are supposed to keep New London in our prayers.

A lot was accomplished at Synod through work, meals and fellowship. New friends were made and old friendships rekindled. It is an experience everyone should have an opportunity to be a part of.
