Minutes of the Annual General Meeting Sunday, January 26, 2020

- 1. The Opening Prayer was led by Rev. Mark Pretty at 11:50 am.
- 2. **Election of chair** Keith Fraser moved and Erica Orlando seconded that Bev Dellapinna chair the meeting. Motion carried.
- 3. **Election of meeting Secretary** Keith Fraser moved and Rick Morash seconded that Lorraine MacLellan be recording secretary. Motioned carried.
- 4. **Corrections and approval of 2018 AGM** minutes It was moved by Tim Edwards and seconded by Erica Orlando that the minutes from last year's meeting be approved as written. Motion carried.
- 5. **Unfinished business from previous AGM** Nothing to report.
- 6. **Business arising from the Minutes** The sound system was improved by turning up the volume and installing a microphone stand. There is no need of a new system.
- 7. **Communications** None
- 8. Parish Assets and Liabilities Included in Financial Report
- 9. Presentation of Insurance Policies Included on page 19 of the Annual Report
- 10. **New Business** Moved by Rick Morash and seconded Kim Branton that all reports are accepted as circulated. Motion carried.
- 11. **Presentation of Audited Financial Statements** Keith Fraser moved and Rick Morash seconded the adoption of the financial Statements. Keith spoke about our investments and where we are going financially. He gave a conservative projection of investments and expenditures, trying to be as accurate as possible. Bev Higgins' retirement from Ways and Means at the end of 2020 will greatly affect the money coming in. It is possible that we could run out of funds in twelve years.

Rev. Mark spoke about the various kinds of ministry we could have in order to reduce costs. This could include shared ministry, part-time ministry or having retired priests perform services. He felt that by having this discussion now, we are being proactive about our finances.

Jinny asked about the discretionary fund. This is classified as "Outreach" in the Financial Statements. Some money was donated to the fund, but there were no requests to use the funds in 2019.

Keith mentioned that we are all getting older and it is harder for us to get things done, with many people getting worn out and tired.

Linda Strachan mentioned the Ladies Group is in the same position. The Ladies Group is down

to half as many members as a few years ago. Bev Dellapinna said it is very important to keep being proactive.

12. **The Report of the Rector** – Rev. Mark Pretty commented that we have had big losses in terms of deaths and people stepping back from duties. Rev. Mark expressed thanks to everyone for all they do, and a special thanks to Rev. Marilyn Hamlin (and Gordon), Rev. David Dellapinna and Donna Ruggles.

On the topic of same-sex marriages, Rev. Mark re-emphasized that Bishop Ron has stated that priests are permitted to perform same-sex marriages, but the Parish must send a letter to the Bishop to confirm what our Parish wishes to do. Bernie Conrad asked why the Diocese doesn't just make a decision instead of leaving it up to the Parishes. Rev. Mark replied that the Bishop wants to leave the Parish the option to decide. There was some discussion on same-sex marriages. It was decided to allow Parishioners until the end of March to express their wishes to Rev. Mark on a confidential basis. At that time the letter to the Bishop will be drafted, based on the wishes of the Parishioners.

- 13. **The Report of the Deacon** Rev Marilyn thanked Rev. Mark. She will continue to be Deacon with some cutback to her schedule and participation. She gets strength from others as well as giving it. We are very fortunate to have good rapport among the clergy.
- 14. **The Report of the Wardens** Bev Dellapinna thanked Rev. Marilyn for all she did. She stated that, prior to becoming Warden; she had no idea how much work everyone did. She thanked Brenda Morash for her years of service on the Administration Committee. She pointed out that we all need to be more aware of burnout. She also thanked Ken Richardson and Bev Higgins for all their help.
- 15. **Reports** Tim Edwards talked about the Property Committee Report. He thanked everyone for all their work and specifically mentioned Keith and Anne Fraser, Bev and Dave Dellapinna and Ken Richardson He also thanked the families who directed memorial donations to the Renovation Fund. He mentioned there were a few small projects planned for 2020.
- 16. **Budget for 2020** Keith explained some of the reasons why the 2019 results were better than budgeted. In particular, we had a number of larger one-time Christmas donations and we received more for the Renovation Fund than we spent. We cannot rely on those same results for 2020.

Keith Fraser moved and Linda Strachan seconded the approval of the 2020 Budget. Motion Carried.

- 17. **Election of Wardens and Members of Parish Council** Linda Strachan nominated Anne Dauphinee as a Member-at-Large. Anne accepted the nomination. There were no other nominations. Tim Edwards moved and Rick Morash seconded the motion that all nominees (including those nominated by the Nominating Committee) be elected. Motion Carried.
- 18. **Synod Delegates** Jinny Giza confirmed she is a Synod Delegate. We will wait to see if Wendy wishes to continue as a Synod Delegate.

19. **Other Business** – Donna Ruggles suggested we cover the cost to enroll Patti Crory in RCCO (The Royal Canadian College of Organists). This will be left to be decided at Council.

Rick Morash moved adjournment at 1:25 PM.

Rector's Annual Report 2020

The first and most important thing to say is a profound thank you to so many who have kept St. Andrew's on its feet through an extremely challenging year. There are so many!

The greatest part of this has been our devoted parishioners who were able to continue supporting the parish financially, whether doors were open or closed! Without you we would not have been able to be there for our community, the sick, the dying, the struggling, and those in many kinds of need. If anything, I am understating the kind of difference you have made in a year when so many parishes in all denominations were not able to self-sustain.

I want to express my deepest gratitude to both our executive and council members. It just wouldn't be possible to list all the responsibilities the executive took on this year. With the pandemic it was impossible to meet as a full council most months. And so the executive shouldered all the administrative and management duties, which extended into every single aspect of running the parish, keeping us safe re provincial and diocesan protocols, and at times making decisions there were no guidelines for, trusting in our collective wisdom and the priority of keeping parishioners safe.

Behind all that, there were uncountable numbers of calls, emails and meetings when possible. No volunteer for leadership positions could ever have expected to see a parish through a global pandemic. And yet, both the executive and council did every step of the way. Our executive has included some permanent and some advisory involvement from our wardens (Ken Richardson, Rick Orlando), treasurer (Keith Fraser), secretary (Wendy Wells), Ways and Means Chair (Bev Higgins), Property Chair (Tim Edwards) and myself. There were also plenty of times when parish council supported and guided parish decisions, via calls, emails and in person when possible. Quite a crew. We have been so blessed!

Another wonderful blessing this year was the always ready and willing worship team. We really did have to go back to the drawing board when the province closed all public worship and faith events. We knew almost nothing about how to digitally record, and use social media to make worship available and accessible to the public!

Thanks to the untiring and always enthusiastic crew we've had in Gordon Hamlin, Bev Higgins and Natasha Pretty as our vid, tech, and website experts; Patti Crory & Sharon MacKenzie who unfailingly provided music and singing all the way through the pandemic along with special pieces, preludes, postludes and a willingness to take on any form of worship we tried; and the Rev'd Marilyn Hamlin who went far, far above and beyond in faithful service as our deacon, sharing in every aspect of worship leadership. Quite a crew indeed. If together we managed to bring the familiarity and sense of our church as our home, to the many that missed both St. Andrews and its people, then we are truly thankful. And we will continue as needed, as things unfold in 2021.

Something of vital importance that changed so fundamentally in 2020 was how we do pastoral care. There were times when those of us who respond to hospital situations, our shut ins, death, family crisis, emergencies, mental health struggles, and the daily needs of parishioners

were severely challenged by the overriding priority of following pandemic safety protocols in order to protect one another.

Many, many of our folks were alone, isolated, struggling and unable to have hospital visits, or even home visits ... even in such overwhelming times as the loss of a loved one. This is something I would never have imagined before lockdowns began. And I know we will see periods of time like this during 2021 as well.

I am so very thankful for the care many of our people continued to provide to each other, whether through prayer, phone calls, emails, or safe visits. I pray no one felt unsupported or forgotten as we continued praying for and caring for everyone, sometimes with such previously unimagined limitations.

I think the thing that I have taken most to heart in our year together in 2020 is that literally everything that might be tradition or normal, whether taken for granted or always appreciated, can change in a heartbeat. This year was in many ways a very unsettling and yet revealing process of peeling back every layer we have, leaving only what is essential and what matters the most about being the parish of Saint Andrews serving the BLTH area. Looking forward to a new year of worshipping and ministering together, and cherishing what we have learned and experienced together this last year.

"Retired" Deacon's Annual Report for 2020

Last year I opened my report with the following words, "2019 was a very special year in the life of St. Andrews Church....100 years old...WOW! Many wonderful events took place during the year to celebrate this milestone."

2020 began on a positive note and we once again looked forward to another 12 months of exciting activities and church-related events. Then, Covid-19 arrived and life as we knew it changed drastically.

I had always related "2020" to having perfect eyesight, great vision. However, I have learned that our vision can change in a heartbeat, and eyesight, which we often take for granted, can become compromised without warning. The year 2020, like one's eyesight, has undergone many changes: changes which took place weekly, daily, hourly and even minute to minute.

Our style of worship here at St. Andrews underwent numerous shifts and changes during the year. We began optimistically in January with our usual Sunday services, gathering at 9:00 am and 10:30 am. Then in March the doors of our church building closed. No more worshiping together indoors to pray, sing, hear scripture read aloud, listen to a sermon, go to Sunday School, or share in Holy Communion. Eventually it became possible for the Clergy to conduct an indoor service which was video recorded and put on YouTube for home viewing. Soon music was added to these services and we welcomed our organist and soloist.

During the summer months when the weather cooperated, which was almost every Sunday, we gathered in the cemetery for some of the most beautiful and uplifting services I have ever experienced. In the Fall, restrictions eased for a time and our hearts were joyful as we again moved inside our church building, being mindful and obeying sanitizing protocols, physical distancing rules and "masking" regulations. Even Sunday School was able to resume. But sadly, the virus took hold of our lives once again and indoor faith gatherings could not continue.

During these many months of constant shifting and changing in the way we worshipped at St. Andrews, one thing never changed and that was the presence of the great Team Ministry. The Clergy, led by Rev.'d Mark; conducted services which were recorded for home viewing. Our services were even available to those living in a senior's complex on PEI and to residents in Melville Lodge. Music always enhanced these services. The wardens, members of the altar guild, ladies group, the Sunday School, the various committees, and our faithful congregation remained focused and committed to keeping the Word of God alive and well.

Members of the parish were contacted regularly by phone, email and regular mail. Visits continued to take place when possible. Letters and cards were sent out. The church website and Facebook kept many parishioners up to date and the church sign indicated whether or not worship was taking place.

As the deacon who had "retired", I still find myself quite busy, leading or participating in services, conducting a funeral or burial, preaching, reaching out to parishioners, and being part of the decision making process in the life of our parish.

Yes, 2020 was a very different and challenging year, but still so special in many ways....ways that highlighted the caring, compassionate, cooperative nature of our church family. Outreach continued, pastoral care work was never overlooked, monetary needs were not forgotten. God was and is still in our midst. We are called into different roles at different times and it is only with God's love that we are able to meet these challenges using the many gifts we have been given. I am truly grateful for the gift of each one of you, my parish family.

May 2021 bring God's peace, joy and love into all our lives, and may we always share that peace, joy and love with one another.

Finance Committee Annual Report 2020

The committee of 2020 was comprised of Warden Ken Richardson, Warden and Chair Rick Orlando, Treasurer Keith Fraser, Linda Strachan and Rev Mark Pretty.

All quarterly meetings for 2020 were cancelled due to the Corona Virus Pandemic. Financial matters were handled by the Council who met fairly regularly in the parish hall, where it was possible to follow all the Covid restrictions. With few church gatherings, no fundraising activities and little activity of any kind, the Finance Committee was not tasked with any discussion requirement that could not be entertained by Council.

The Treasurer's Report includes all the key financial activity for the year 2020. The main points of interest that make 2020 a very unique year in our parish history include the pandemic financial subsidies from government and the diocese. Revenue was down as were donations, and we continued with the pattern of disbursements exceeding revenues. Our investment income was relatively healthy, as the markets remained strong for most of the year.

The long term prognosis remains the same, and that is that a decision will be needed soon to either draw down on capital or revert to part time ministry, or some combination of all the cost cutting measures.

Everyone is hopeful that 2021 will bring an easing of restrictions, accompanied by some measure of return to normalcy in the war against Covid. All parishioners are encouraged to be patient, follow the pandemic guidelines and to never become complacent. This is a deadly disease and many of the older parishioners remain particularly vulnerable.

St. Andrew's Ladies Group, once referred to as the "Young Ladies Group", have twelve very dedicated members and one Honourary Lifetime Member. We only met twice this year due to the Covid-19 pandemic.

In January we held our Annual Meeting and our Executive remained the same. President – Wendy Wells, Vice-President – vacant, Treasurer – Linda Strachan, Secretary – Anne Fraser. We no longer require a phone committee or "call girls" as everyone is now on line.

We met again in March and planned some events which never materialized. The only income we had this year came from 3 funerals we catered. We were able to give the church \$1600 but were unable to reach our commitment of \$2000.

We kept in touch throughout the spring and summer through email. In the fall through email, we were able to do some of the things we always do. We collected items for a basket for the Marguerite Centre. The list they gave us was different than other years. It included things such as school supplies, craft supplies, towels and facecloths, and even small used appliances. They need these things for setting up the residents in their own apartments once they have completed the program at the center. A few of us met and did up an overflowing basket of items which was delivered to the Marguerite Center by Erica Orlando.

We also sold calendars again. We polled the congregation through email to see how much interest there was. We ordered 30 calendars and sold them all as soon as they arrived. This is not a big fundraiser as the calendars cost \$5 each and we sell them for \$6.

Our next project in the fall was the Mission to Seafarers Christmas shoebox campaign. When church opened in the fall for a few weeks of in person services, we were able to collect items in the bin we put in the porch. Since there was a restriction of 5 people to gather when we packed the boxes, 5 of us met on the first Friday of December and packed up 60 boxes for the Seafarers. We sent leftover items to the Mission along with the boxes. Many thanks to Gordon and Marilyn Hamlin for taking the boxes to the Mission every year for us. A big thank you to our Honourary Life Member, Flos MacFarlane, for collecting and wrapping the boxes for us each year. This is what shared ministry is all about.

Since there were no in person Christmas services, a few of us got together and decorated the altar for Christmas for the video service. We set up the Nativity and placed poinsettias on the altar in memory of all our parishioners who have passed away over the past two years.

We are not sure what 2021 will bring us. For now, our executive will remain the same and we are hoping to have an in-person meeting in February, if all goes well with the COVID-19 numbers.

Thanks to all who have helped us in the past and to those who so willingly donate items when we put out an appeal for help. May God shine his light on all of you!

Pastoral Care Committee Annual Report 2020

The Pastoral Care Committee provides support to parishioners in a number of ways during all twelve months of the year. Phone calls are made weekly to those families listed in the prayer cycle as well as others in need of support.

Contact is also made by email and mail and includes Get Well, Thinking of You and Sympathy cards. Birthday cards are sent to those known to be ninety years of age and older.
