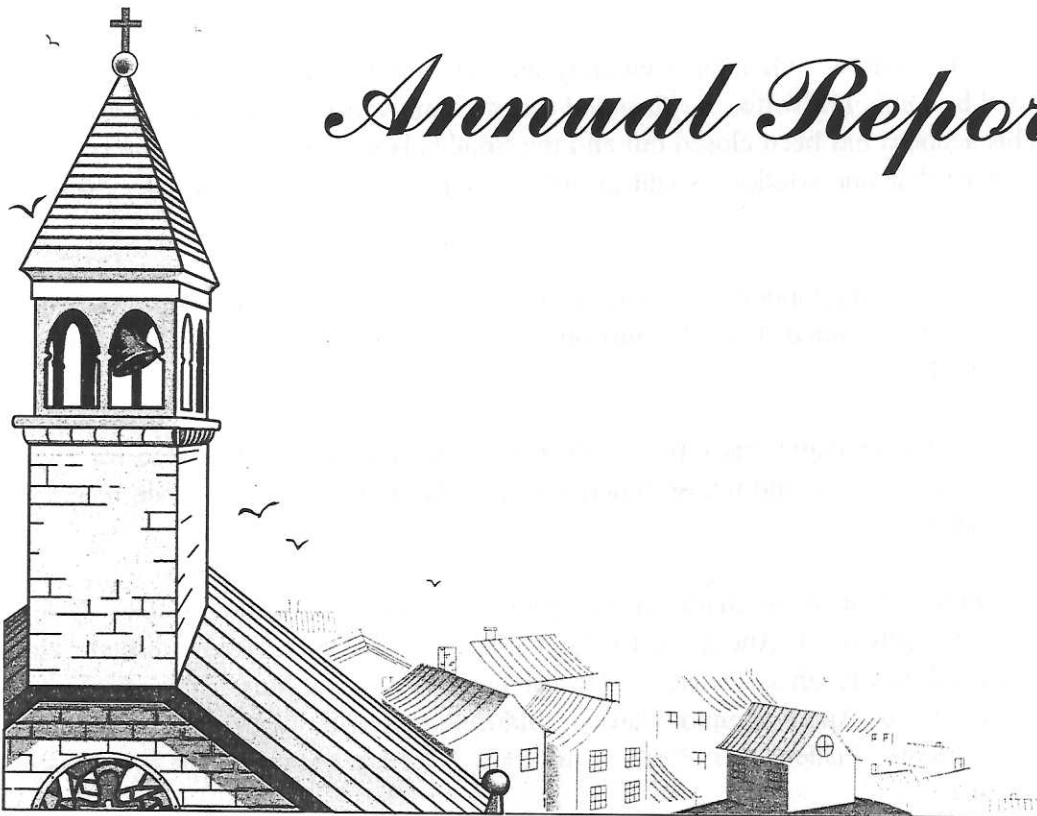

## PARISH OF TIMBERLE WITH LAKESIDE ANNUAL MEETING - February 6, 2000

The meeting took place in St. Andrew's Church hall at 12:00 noon, following a shortened service of Holy Communion in the church. There were 31 members present.

Rev. Walker opened the meeting with prayer.

Gordon moved, Myril seconded Arthur Lewis act as chairman of the meeting. Motion carried. Wendy Wells moved, Lisa Elliot seconded, Edith Steffens act as secretary of the meeting. Motion carried.

Rick Orlando moved adoption of the minutes of the last annual meeting as circulated in the annual report. Seconded, Gordon Hamlin. Motion carried.

Peter McAuley moved, Tim seconded the reports to be received into the meeting as circulated in the Annual Report. Motion carried.

Item 6 on the Agenda - Insurance coverage: Gordon asked if the coverage was increased after the new windows were installed. Keith replied that the Finance committee has met and this will be looked into soon.

Item 7 - Financial reports: Keith moved adoption of the Parish reports for 1999, seconded by Myril. In answer to Gordon re increase of \$5000. for stipend: the diocese has set the amount, and Keith included the top amount in the budget. Rev. Walker added that the stipend has not increased over the last few years.

Keith moved adoption of St. Andrew's General, Cemetery and Memorial funds as circulated in the Annual Report. Seconded by Doris DeWolfe. Keith stated that the Anniversary fund met its objective with a small surplus. This account has been closed out and the small balance transferred to the general account. Keith reminded us that one window is still available for purchase as a memorial. Motion carried.

St. Luke's Financial: Jinny moved adoption of the General, Building and Memorial Fund reports as circulated in the Annual Report; seconded, Ruth Thompson. St. Luke's ended with a surplus, with all expenses paid. Motion carried.

Rector's Report: Rev. Walker began his report with prayer and a moment of silence for four people who passed away in the past year and whose funerals were held in the parish. He then read his report as printed in the Annual Report.

Wardens' Report: Arthur reiterated his thanks to the people for giving so freely of their Time, Treasure and Talent, and, especially in St. Andrew's, for the big projects that were accomplished. He thanked council members; especially Keith as Treasurer. He also thanked past wardens, Tim and Wendy who were very helpful, also Peter McAuley as junior warden. Judie expressed her thanks to Rev. Walker for his advice and encouragement. Challenges of 2000: go forward, selection of new rector and we are well positioned to go forward.

Item 10: Peter moved, Rick Orlando seconded adoption of all the other reports except the budget.

Jinny asked about the Youth Conference mentioned in the minutes; Judie replied that there is a Diocesan conference scheduled for sometime this year.

Judie thanked Ron for his help and support in her ministry. There are many in her position who do not have the support and encouragement she has enjoyed. Motion carried.

**Parish Budget:** Keith moved adoption of the parish budget on page seven of the Annual Report. Seconded, Tim Edwards. Keith emphasized that there is a sliding scale for rector's salary; the maximum occurs at 15 years experience, and the maximum is in the budget. Bernie Conrad mentioned that there will be some repairs to the rectory this year. Motion carried.

**St. Andrew's Budget:** Keith moved adoption; seconded, Jinny Giza. Motion carried.

**St. Luke's Budget:** Jinny moved adoption of the budget for 2000. Seconded, Fonny Miller. Motion carried.

## NEW BUSINESS

1. **Rectory:** Arthur said that the rectory may or may not be used by the new rector. A housing allowance may be required in that case. He requested opinions on what should be done in this case. Bernie asked what the housing allowance would be. Keith had inquired from the Diocese and found there is no set amount, but the usual is about \$1100 per month. Keith checked past year's expenses and found the average cost of operating the rectory is about \$4000 per year. Gordon Hamlin was not in favour of renting the rectory in case the new rector does not want to live there. Bev Delapinna asked if there was a move toward not providing a rectory; Rev. Walker said that more and more were going this route. He said that clergy who were receiving this amount (\$1100.) found it was not enough. Rev. Walker stated that not having a rectory removes the clergy from the church; he preferred living in a rectory. Tim asked if in Ron's ministry, it was an advantage to have an office in the rectory, or if it would have been better to have an apt. in which case the meetings would be in the church office. He met usually in his study in the rectory. Bernie asked if, if a rector has his own house, there were any guidelines as to location of his home. He thought it would be more cost-effective to keep the rectory. Keith moved that we defer doing anything about the rectory until such time as circumstances require a change. Gordon Hamlin seconded. (This is because it would be cheaper than giving a cost allowance). Ron added that we should be prepared to negotiate if the person we really want does not want to live in a rectory. Bernie asked by whom this would be decided; Arthur replied that a parish meeting would be called to decide this.

Motion carried.

2. **Parochial Committee:** The profile has been completed and submitted to the Archbishop and. Notice of the vacancy will be sent to the Diocese and the Ecclesiastical Province of Canada with a deadline of March 3 for application. Peter pointed out that even if a selection is made by April 30, the new incumbent may not be here for two or three months. The Archdeacon indicated that there may be a delay (i.e., for school-age children). The earliest date for the arrival of the new rector will be June 1, because Rev. Walker's retirement is effective June 1.

## ELECTION OF OFFICERS

The Nominating Committee has found people to fill all positions except that of Junior Warden. Arthur asked for nominations for this position. Keith nominated Wendy Wells. Seconded, Tim Edwards. Bev nominated Myril Wells. Myril declined. There is at present only one Synod delegate. Wendy nominated Erica Orlando. She said she would consider the nomination.

Rev. Walker thanked all for attendance at the meeting and for their help, support and participation.

Gordon moved the meeting adjourned at 1:30 and the meeting closed with the Grace.

## Rectors Report 2000

My dear people:

Greeting to you in the name of our Lord Jesus Christ. It is with thanksgiving to God, that I address you in my role as Rector of the Parish of Timberlea with Lakeside, and particularly as we assemble on the occasion of the annual meeting.

Indeed this past year has been a time of adjustment and transition for both the parish family and myself. As a parish family you said farewell to your beloved priest and rector, Fr. Ron as he retired from active ministry. Fr. Walkers' ministry touched the lives of many people and will forever be etched in the hearts and thoughts of our people. Again, we commend Fr. Ron and Gerry to our Lord and wish them years of fulfilling retirement.

As rector, I am profoundly blessed to be assisted in ministry by our associate priest, the Rev. Judie Lafford. Rev. Judie and I have made every effort to be a "role model for shared ministry". A sub committee of Spiritual Development, this group is appointed by the rector to assist him in his role as the chief liturgical officer of the parish, subject to the bishop. In our Anglican tradition, it is important to establish strong standards of worship in our faith community. Your present rector shares this with his associate priest and the Liturgy Committee. This practice will not change during his tenure of office.

The future awaits us with complexities and polarizations of the various exigencies of life. Together as the Lord's family, we will endeavor to be faithful to the one who has called us to be 'one,' Jesus the Christ.
