RECTOR'S REPORT TO THE ANNUAL GENERAL MEETING OF THE PARISH OF ST. ANDREW'S TIMBERLEA &

JANUARY 28TH, 2007

ST. LUKE'S BEECHVILLE

"And now faith, hope, and love abide, these three; and the greatest of these is love."

1 Corinthians 13: 13

In the lectionary proclaimed in our churches this morning this well known verse from Paul's first epistle to the Corinthians was read. As I reflect on my first full of year of ministry among you I am reminded of the profound truth these words convey. As a people of faith, just over a year ago, we embarked on a journey with a hope that together we would build up the body of Christ, his Church, in this community. With faith as our guide, and hope as our goal we need only love to make our journey possible. With what I have witnessed among you, a generous gift of love, and with the guidance of the Holy Spirit to lead us we are poised to continue our journey, confidently proclaiming God's glory in this community and in God's world.

My continuing education through the Interim Ministry Network suggests that one important component of a healthy congregation is identifying and coming to terms with its history. I believe that we have been intentional in doing that over the past twelve months. We acknowledge that prior to my appointment as rector there was a period of instability, the result of two incumbencies that ended prematurely owing to unfortunate circumstances. We cannot change the past but we can learn from it. To your credit is the strong history which provided a solid foundation, a rock to stand on that helped you through difficult times. It is that foundation that gives me great hope and confidence as your parish priest. It is also timely here to make mention of a joyous moment of the past twelve months with the return of the Reverend Ron Walker as an Honorary Assistant Priest. We are blessed to have Ron and his gifts for ministry among us.

Another component of a healthy congregation is the establishment of connections within the denomination and the ruling body, in our case the Diocese. This parish has been attentive to maintaining good relations and participating in programming as suggested by our diocese. The Leap for Faith Campaign, Mission to Seafarers, PWRDF, Phoenix House, are more than outreach they are programs that identify us as Anglicans who support the goals and mission of our Church.

Our church has long been one that supports both the threefold ordained ministry of bishops, priests and deacons and the ministry of lay leaders with the intended purpose of "responding to the call to be helpful in the building up of the Body of Christ." (Lay Readers Handbook) Here in our parish we have many capable and willing lay leaders who participate in many aspects of parish ministry. Respecting the role these leaders now have and being true to traditions of our church I look forward to our Bishop licensing persons as Lay Readers with the intent of building on programs now offered and by working with such leaders so as to more deeply experience the richness of our faith and our service to God and one another. At Parish Council in December the names of Wendy Wells and Marilyn Hamlin were approved to begin the licensing process. A program of study exists for persons who feel called to the ministry of Lay Reader. I look forward to the potential for this ministry and invite others who feel called to explore there call with me.

Yet another, the most important, component of a healthy congregation is a clear understanding of where it is going and a plan how to get there. I began talking about a journey. Before any journey begins we need a travel plan and the tools and equipment to get us there. As a final phase of my continuing education for the "Interim Ministry Network" program I hope to develop with you a strong and meaningful statement of our purpose for the church as an instrument of God's grace for our community. In addition to this work we will continue the ongoing work with Janet Marshall, a

consultant with *Potentials East*. This regional endeavour seeks to help us identify what we need to have and what we need to do to continue to build our church.

One area that Janet has asked us to look at is property. We need to ask the question, how do our properties help or hinder us in building up the body of Christ? That is a tall question. We have recently, at our last council meeting, made a motion to improve our kitchen with the installation of an industrial dishwasher and improvements to the plumbing. The property committee has worked hard to continue the general maintenance and upkeep of our buildings and property. While maintaining and improving what we have is important I believe it is important that we create a vision of our facilities needs bearing in mind the people and church of the 21st century. I look forward to working with the property committee and the congregations in developing such a vision.

Keith Fraser moved, Wendy seconded, Barry Fraser chair the meeting and Edith Steffens act as Secretary. Motion carried.

Rick Morash moved adoption of the minutes of the last meeting. Seconded by Doris DeWolfe. Doug Gillett commented that he was told at last year's meeting that the money from rectory sale is guaranteed. That is not actually the case. Motion carried.

Unfinished Business from Previous Annual Meeting

Business Arising from the Minutes

Brian Travis gave a report on the progress of kitchen discussions. After a number of meetings, we have obtained a quote and are working on obtaining more. Over the past year there has been discussion on other options — construction of a hall, etc. The suggestion now is to break the project up into several phases: upgrade the present kitchen, improvement of the hall, separate hall building. This long range plan has no time limit at present. He hopes within about 3 months to have three sets of figures for our consideration. The figure is probably in the range of \$32,000. Brian displayed a proposed plan for the renovations. Keith added that he did some preliminary investigations, discussing with St. Nicholas in Tantallon, whose hall is approximately the size we need. Their costs were about \$400,000 three years ago. He invited anyone who would like to do more investigation to obtain firmer costs, to feel free.

Renee asked if renovations to the balcony area are still planned. Brian replied that is on Property Committee's agenda.

Insurance Policies – information is in the Annual Report. Bernie Conrad noticed that there is no value for Contents at St. Luke's; Keith replied that St. Luke's people made the decision to not cover the contents, due to the rising of insurance premium costs.

Keith moved adoption of the Parish Financial Report for 2005. Seconded by Jinny. The statements were audited by Doug Gillett. Motion carried.

Keith moved adoption of St. Andrew's financial report for 2005 for the general, cemetery and memorial funds. Seconded by Brian Travis. The report was audited by Tom Richardson. Motion carried.

Ginny moved adoption general building and memorial fund. Audited by Doug Gillett. Seconded by Tom Richardson. Motion carried.

Rector's Report, Associate Priest's Report, Wardens Report

These reports were left to parishioners to read on their own.

Wendy Wells moved, Ken Richardson seconded that the remaining reports be adopted. Motion carried.

Budget for 2006

Keith moved adoption of the parish, St. Andrew's and St. Luke's budgets for 2006. Seconded by Wendy. The Finance Committee essentially made break-even budgets for the two churches, leaving the parish with a shortfall, i.e., a deficit, but with enough at the end of the year to meet our expenses. Motion carried.

Election of wardens

The nominating committee presented the name of Janet Benight. Doris DeWolfe nominated Bernie Conrad. Seconded by Myril Wells. By secret ballot, Janet Benight was elected warden.

Election of council members

Wendy nominated Bernie Conrad as member-at-large. Bernie is willing to stand. There was considerable discussion on whether the numbers should be increased up to nine. Wendy moved that council may have up to nine members-at-large. 19 for, 13 against the motion. Seconded by Rick Morash. Motion carried. No further nominations. Bernie is member-at-large by acclamation. Bernie's term will be decided at the next Council meeting.

Synod delegates

Leila Schwartz is a possible Youth Synod delegate, depending on the date of Synod. Wendy Wells and Doug Gillett have agreed to serve. No further nominations.

Election of secretary of parish

The nominating committee put forth the name of Edith Steffens. No nominations from the floor.

Treasurer: Keith Fraser nominated by the nominating committee. No nominations from the floor.

Auditors: Tom Richardson, Doug Gillett. No nominations from the floor.

Diocesan Times Correspondent: Doris De Wolfe. No nominations from the floor. The above (secretary, treasurer, auditors. Moved by Brian, seconded by Erica that the above are acclaimed to their positions.

Envelope secretaries: tom Richardson and Linda Strachan. No nominations from the floor. Wendy moved nominations cease. Seconded, Rick Morash.

In 2010 there will be a celebration of the tri-centennial. There is a tri-centennial committee being formed for 2010. The bishop has asked that we nominate one person from each parish who would be willing to work on that committee. Rick nominated Wendy Wells. Doris DeWolfe seconded. Rev. Rev. Mike expressed satisfaction with the willingness of parishioners to volunteer.

Keith moved adjournment at 1:00 and the meeting closed with prayer led by Rev. Mike, followed by the Grace.

In 2006 the Committee reached out from our pews in the following areas: - the annual fund-raising for the Haitian Orphan Feed Program, support for the local area Food Banks by means of contribution and distribution, monetary donations to the "White Gift" Sunday towards Feed Nova Scotia's Turkey Project, plans encompassing regional outreach, fulfillment of the "Christmas Wish List" for Phoenix Center, continuation of local Ecumenical participation, and contributions to the Marguerite Centre.

An Easter Tea was held on April 8th at the church hall as a fund-raiser for the Haiti Orphan Feed Program now administered by the pastor's widow Raymonde Eugene of Eben-Ezer Evangelical Baptist Church in Cap-Haitien, Haiti. After expenses, \$413.96 was the amount raised.

Our partnership with the Local Area Food Bank, located at Sacred Heart and administered by the St. Vincent de Paul Society, is represented at their meetings the third Monday of every month including your Outreach Committee participation in visitation of those requiring emergency help on a short-term basis. In addition to emergency groceries, their varying needs may be help with expenses including rent, oil or power bills. Your Local Area Food Bank also conducted their annual Christmas Outreach and our committee assisted with its organization, distribution of gift certificates and groceries to 15 families of all denominations in our nearby communities.

White Gift Sunday on Dec. 10th this year raised \$250 to support Feed Nova Scotia's Turkey Project where \$47,000 was spent the previous year to buy turkeys for needy families across the province. Feed Nova Scotia BLT Food Bank was newly minted in January, 2006. Individual parishioners have kindly offered to volunteer in organizing regular distribution through Feed Nova Scotia's BLT Food Bank to needy families from Trinity United Church Hall on the second Tuesday of each month. Feed Nova Scotia generously provides a truck load of food that includes produce, i.e. lettuce, potatoes, turnips, apples, along with bread, frozen pies, canned goods, lunch snacks, and paper products. Families must be registered. The service is long-term.

On May 23rd, a regional outreach meeting was held at the home of Rev. Mike and Rev. Marion. In attendance were Dawn and Maxine of St. Thomas' Anglican Church in Fall River. The meeting was to raise involvement of Anglican outreach in order to make it more visible to parishioners by direct involvement with local and universal Anglican projects.

As a result of this meeting, we had the privilege this Fall of having Colin MacDonald, Case Manager of Phoenix Centre for Youth, as our guest speaker in our Parish. He gave an insightful talk on the seven programs that are available for homeless youth between the ages of 16 to 24 years of age. Our church decided to make their Christmas more merry by fulfilling their "Christmas Wish List". Such items as hats, mittens, gloves, baby sleepers, pampers, toys, soaps, hair shampoo, tooth brushes and paste, gift certificates for Tim Horton's, Subway and the movies, potatoes, candy, clothing, books, Christmas baking and much more were all brought in by the generous efforts of St. Luke's and St. Andrew's. The Executive Director, Jackie Pidduck, and Colin were ecstatic by the wonderful response and convey their thanks to everyone involved.

Last month, our Ecumenical Service called "Advent Lessons & Carols" for our Local Area Food Bank at Sacred Heart raised \$331. Guest Readers and Choir Members from Trinity United, Timberlea Baptist, and Sacred Heart were well represented.

Once again, the choir was in attendance for Lenten mid-week services and held an abbreviated practice after the services. This year, on the request of Rev. Mike, the choir did not disband for the summer; instead, those members who were present made their way to the choir stalls. This was much appreciated by the organist, the rector, and I am sure by the congregation.

Last spring, the choir requested new *Mission/Living Praise* hymn books with music, and an appeal was put out to the congregation for memorial donations to purchase them. As a result of the generosity of the congregation, fourteen books were purchased as memorials to loved ones; they were dedicated in the fall and have been used several times by the choir. In Advent, an Ecumenical service of Advent Carols and Lessons was held. The offering for this service was designated to support the Sacred Heart Food Bank. St. Andrew's Choir, augmented by singers from other churches in the area, led the singing. We were delighted to have Tim Edwards, with his flute, present at this service to enhance the music. Tim was present again on Christmas Eve, at the 10 o'clock service; his flute added so much to the music of that evening. Thank you so much, Tim.

As in past years, members graciously took time from their busy schedules to provide a choir for any funerals that took place in the church during the year; there were at least five funerals. Their dedication is much appreciated by me and the clergy, as well as by the bereaved families.

The organist and two ladies from the choir helped the Sunday School children learn Away in a Manger for their Pageant, and the choir provided music for the Pageant on Christmas Eve.

After the last choir practice in December, the choir (augmented by Jim Polkinghorne and Joan Hagen) surprised Weldon and Emily Rhyno by arriving at their door unannounced to sing some Christmas carols. Weldon was ill for a few weeks and was sadly missed. Thankfully, Weldon's health improved immediately.

Spiritual Development Committee Report - 2006

The committee consists of Rev. Mike, Rev. Judie, Brenda Morash, Sharon Polkinghorne, Jean Schwartz, Edith Steffens and Wardens Linda Strachan and Janet Benight.

Meetings were held on February 14, June 6, October 11 and November 22.

Edith Steffens agreed to act as Chair, and Linda Strachan agreed to administer the Flower Fund.

A Pot Luck and dance was held on February 28 and much enjoyed by about 50 parishioners of all ages. A second Pot Luck/Dance was originally planned for December 8, but later changed to early January.

Decisions and/or motions to Council made by this committee were:

Lenten mid-week services to be continued at St. Andrew's at 7 p.m. on Wednesdays;

the Prayers of the People roster, as well as that for the readers, should be under the Spiritual Development Committee. During the summer, we continued with 4 people scheduled to do the readings and prayers each Sunday;

the phrase "and their families" was re-instated in the Parish Prayer Care section of the pew bulletin;

at Rev. Mike's request, the choir continued throughout the summer, even if only three or four were present. This was much appreciated by clergy and organist;

Sunday, September 17 was named Celebration Sunday, with special celebrations – games, a barbecue – held after the service, and much enjoyed by all;

service times have been posted in the "events" sign by the highway, rather than having the empty board displayed in between parish events;

the time of Sunday School was changed, the children going directly to Sunday School at 10:30, and coming up to church at Communion time, enabling the teachers to complete the lessons; four Bibles have been ordered for the Sunday School;

the names of children participating in the Family Service will be printed in the pew bulletin. The children will act as greeters and help with readings and at the offertory. October 29 and November 26 were Family Services the social hour afterward provided by the Ladies Group and Council:

the 8 o'clock service at St. Andrew's has been moved to 9, the BCP continuing to be the book used:

the late Christmas Eve service was moved to 10 o'clock. There was only one service in the parish on both Christmas Eve (morning) and New Year's Eve, as well as Christmas Day;

the planned Advent Bible Study was cancelled, to be replaced by a Lenten one;

the cemetery service planned for August was cancelled for this year.

Rev. Mike has attempted several times to contact Sr. Evelyn Williams at the Seton Spirituality Centre in Terence Bay, but has been unable to reach her. He will try to determine the status of our Mission Statement, it now being three years since the workshop was held.

There was considerable discussion regarding the institution of Lay Readers in the Parish. It was emphasized that no existing ministries would be taken away if the program becomes a reality. The names of interested people were brought forth to Council, and an announcement will be made asking if others are interested. A list of duties will have to be prepared before proceeding further.

ANNUAL REPORT OF SYNOD HELD OCTOBER 12, 13, 14, 2006

The 139th Session of Synod was held in October at Dalhousie University. The theme of this Synod was "We Journey on by Stages". This Synod marked the 150th Anniversary of Synod in our Diocese.

There were 15 motions put forth at this Synod. The following motions are of particular interest to our Parish. Motion 4 has amended Canon 16 in regards to applications for exemptions to 60 days after the approval of a project or purchase. Motion 6 amended Canon 35 in regards to the number of parishioners required to request a parish meeting. Motion 7 changed the time to 60 days in Canon 25 for submission of a parish profile. Motion 14 has revised Canon 35 in regards to the making, amending and repealing of by-laws and to the election of officers.

Our special guest at Synod was our Primate, the Most Rev. Andrew Hutchinson, who preached at the Synod service on Thursday evening. Our keynote address was given by Bruce Rockwell who spoke to us on Stewardship. We had presentations from the Atlantic School of Theology, Campus Ministries and Janet Marshall. Our new Youth Ministry Coordinator, Michael Janz spoke to us about the things he has been doing with the youth of our diocese. Some of the young people shared their experiences with us from their attendance at different youth events.

We had presentations on the 2010 Celebrations, the National Church pilot project, "Letting Down the Nets" and the Primate's World Relief and Development Fund. The logo of our 2010 celebrations was revealed with the theme "A Journey Just Begun" from 1710-2010. We were reminded of the Aids pandemic in Africa with a display of posters set up in the meeting room.

We heard from the Leap for Faith committee. We have reached 85% of our goal of 3.3 million. The Ministries Committee gave a short talk and marked January 7, 2007 as Ministry Sunday. We also heard from the Cursillo movement. They will celebrate their 25th Anniversary in September 2008 at the Tatamagouche Center.

All in all, this Synod was packed with lots of informative and interesting events that will be happening in our Diocese over the next few years. Synod is a great experience for those who attend. It is a time of worship, fellowship, business, guest speakers, good food, entertainment and making new friends.

ANNUAL REPORT OF REGIONAL COUNCIL FOR THE YEAR ENDING DECEMBER 31, 2006 FORT SACKVILLE REGION

Regional Council met three times in the year 2006. Our first meeting of the year was held in June at St. Andrew's Church in Timberlea. Janet Marshall of Potentials East was our guest speaker at this meeting. She spoke to us about the proposal for our Region of "Holy Conversations – Preparing for Growth". She explained what it entailed, the timelines we would be looking at and the cost. Then she tried to firm up commitments from the various parishes in our region in regards to participation. At this meeting we also discussed Congregational Vitality and how we might help those parishes who are not able to meet their financial commitments.

In September we met at St. Thomas Church in Fall River. This was a Pre-Synod meeting. Synod was held in October at which time we marked the 150th Anniversary of Synod in our Diocese. We went over the motions that would be presented at Synod. We also were given the Bishop's Itinerary for the Region of Fort Sackville.

At our September meeting Rev. Mark Kingsbury talked to us about "Letting Down the Nets", a Stewardship Program coming to us from the National Church. There will be Pilot Projects held in six dioceses. Our Diocese will be participating in this project and our Region is one of three regions that will be taking part. This project will include education of Stewardship for both clergy and laity.

In November, we met with our Bishop, the Rt. Rev. Fred Hiltz. Our evening began with the celebration of the Holy Eucharist. Bishop Fred spoke to us about Healthy Congregations, Healthy Leadership and Embracing Young People. We heard how four parishes in the Chebucto Region are working toward becoming one and how Janet Marshall is working with eight parishes who are responding to growth. He spoke to us about the "Letting Down the Nets" project. He shared his concern with us about clergy retirements. There will be a Stewardship Education program called "Companions on the Way" with Charles O'Neil as the head beginning in the next few months. Bishop Fred spoke to us about General Synod coming up in June, 2007 in Winnipeg and the Lambeth Conference in 2008.

We have lots of exciting things happening in our Diocese and our Region. Our Bishop thanked our Archdeacon, Rev. Ron Cutler and our Regional Dean, Rev. Mark Kingsbury for their leadership in our Region.
