

Rectors Report to the Annual General Meeting Parish of Timberlea-Lakeside

Greetings:

The collect for the Sunday between October 16th - October 22nd, one of my favourites, reads as follows:

Almighty and ever living God, increase in us your gift of faith, that forsaking what lies behind and reaching out to what lies before, we may run the way of your commandments and win the crown of everlasting joy; through Jesus Christ our Lord, who lives and reigns with you and the Holy Spirit, one God, now and forever.

- Amen BAS pg. 387

The tone of that collect is appropriate to the circumstances as I prepare this report for the Annual General Meeting of the parish. As you receive this I will no longer be rector of the parish having retired as of December 31st, 2013.

Almighty and ever living God, increase in us your gift of faith. What a joy it has been for me watch you grow in faith!! To watch you grow as you find new ways of expressing your faith, new ways of encountering God, new ways to enrich your minds and open your hearts to the awesomeness of all that God is and all that God can be. But as important as it is to know God it is as important to know ourselves. Faith is a call to action. God without man will not - man without God cannot. (Augustine)

That forsaking what lies behind. This is the one line from the collect that causes me a bit of hesitation. Forsaking is a bit too forceful. Like any "good" Anglican forsaking the past can be a challenge. Matter of fact our Anglican identity is rooted in the past, and there is nothing about it that needs forsaking. We have a long and proud heritage, not without it's struggles, but certainly not without it's merits either. Perhaps I am a bit biased, but I believe, given the choice, I would be an Anglican, appreciative of our foundational building blocks, scripture, tradition, reason and experience.

On yet another level the word forsake comes across too strongly. I was your rector for more than eight years. I will not forget you. I will watch you with great interest and pray for St. Andrew's. Our past, like the past of our Anglican Communion, has not been all smooth sailing. But there were far more calm days than stormy ones. St. Andrew's is blessed with a great heritage of strong leadership, a heritage of willing and capable volunteers, a heritage of care for one another and willingness to heed

God's call to reach out and share with others in need. Don't forsake these qualities that help define who you are. Rather build on these strengths, which are many, to pave the way for service and witness here in God's kingdom.

Unfortunately, sometimes, the things that define us are not life giving. That's where the forsaking part does make sense. There is a general malaise present today in the institutional church. We have been in a period of declining attendance, declining revenue, declining influence. Faced with this reality I fear that we have become discouraged about our future and complacent, accepting what we believe inevitably will be. This is, at times, reflected in our conversations with one another as well as with those who do not belong to our community. To an outsider we might appear to be a sinking ship. In fact we don't know what tomorrow holds, so let's not hasten our demise with negativity by pretending that we do. Perhaps our ship will sink. It has before, it will again. However, if we are true to our Christian faith we should believe that it will be rebuilt to sail again. That is the message of Easter, the message of resurrection and hope. I pray that you might know that hope, that you will hear Jesus' message as he promises, "I will always be with you." Put on that face as you go about the routine of daily life, and you will become an invaluable evangelist living Jesus' command, go and make disciples of all the world.....

Reaching out to what is before... There was a song a number of years ago that had the line, my future is so bright I have to wear shades.... As I wrote above no one knows what tomorrow will bring. But we do know what we have today. And, to a large degree, tomorrow, unpredictable as it is, depends on what we do with what have. Jesus instructs us "not to hide our light under a basket." We are not called to be simple bystanders sitting idly by and waiting for God to give, we are called to be partners with God, co-creators alive today that we might help shape tomorrow. You have heard me say this many times but it bears repeating. A quote attributed to Abraham Lincoln: "A miracle is not God doing the will of the people, a miracle is the people doing the will of God." God has blessed this parish with great gifts. You will soon welcome a new rector who will bring his own gifts to be added to the toolbox. The toolbox is well stocked. You have the tools to reach out for what is before, whatever that might be, with confidence and hope.

Thank you for your service in witness to the gospel of Christ during the year 2013. Thank you for eight years of service while I was your rector. I pray for you and for your new rector, Mark. I will respect this new ministry limiting contact with the parish to occasions when I might be invited by Rev. Mark. Hopefully, that includes preaching this coming June when Toronto raises the Stanley Cup. Ever the dreamer....

May God continue to bless you and the ministries that take place in the parish of Timberlea-Lakeside.

2013 Deacon's Report - Annual Meeting - Saint Andrews Church

2013 WAS A BUSY YEAR. As a member of the Clergy Team, I continued to work with, and under the guidance of, Rev. Mike and/or Rev. Judie. During Sunday liturgies, I proclaimed the Gospel, prepared the altar for the Great Thanksgiving, performed the Ablutions, dismissed the congregation, and attended to other duties whenever necessary. I felt privileged to be part of services such as Funerals, Weddings, Baptisms, Ecumenical, Blue Christmas and Remembrance Day. PASTORAL CARE duties took me to the hospitals, nursing homes and to shut-ins. I shared in the ministry of bringing Communion to those who cannot attend church. We take Holy Communion to residents of Melville Lodge once a month along with music and scripture. During the Advent Season I attended the Family Dinner at Melville and brought greetings from St. Andrews Church. It was an honour to say the "Grace" at this celebration.

I visited BLT school on a regular basis since our church supports their Breakfast Program. In 2013 the congregation contributed \$1,194.23 to this program. We also enjoyed the BLT Honour Choir when they attended one of our Sunday morning services this past year. OTHER AREAS in which I was involved at St. Andrews are Parish Council, Spiritual Development, Pastoral Care, assisting with music when called upon, completing monthly activity records, preparing schedules, Book Study, Bible study, preaching, taking part in parish events, regular meetings with Rev. Mike and Rev. Judie and the Wardens.

I attended Regional Events: Educational and Retreat Weekends for Deacons and/or NSOM, Clergy conferences, Clericus, Regional Council, ordinations, ACW Information evenings, Integrity Services and New Year's Services at the Cathedral. I contributed to the Deacon's Bench in the Diocesan Times and am involved in preparations for the Canadian Deacons' Conference to be held in Halifax this summer. I have met regularly with a mentor for the newly-ordained. AS AN ASSOCIATE member of the Sisters of Saint John the Divine, I had the opportunity to attend a retreat and an educational day, and offered my support through prayer and donations. I am a member of the DiocesanVocations (Discernment) Conference Committee. The Conference takes place each August and at present our committee is examining ways to up-date materials and agenda for upcoming conferences.

During the past year I have been grateful to Rev. Mike for his support and the opportunities he has given me to gain experience in my role as a Deacon at St. Andrews. I have felt blessed to be able to minister beside my sister-in-Christ, Rev. Judie. Her love, friendship and professionalism are deeply appreciated. I give thanks to the wardens, and to the parish for the many ways in which you have shown me respect and love and allowed me to minister to you as your Deacon. Thank you for these wonderful gifts.

FINANCE COMMITTEE ANNUAL REPORT 2013

The Committee for 2013 consisted of Keith Fraser, Jean Schwartz, Treasurer, Bev. Higgins, Rick Orlando, Warden Linda Strachan, the Rector, Rev. Mike Conrad, and myself as Chair.

So you understand the mandate of the Finance Committee I will start with the Terms of Reference for the committee as approved by Parish Council on Thursday December 8, 2011.

St. Andrew's Anglican Church Finance Committee Terms of Reference

- 1. Establish a parish budget for each fiscal year.
- Monitor the annual budget by comparing expenditures to budget line items and by comparing figures by fiscal year quarters, year to date and previous fiscal years and reporting periods.
- 3. Report situations, trends, anomalies and any areas of concern to parish council in a timely fashion by way of accepted accounting practices and reporting forms.
- 4. Prepare and present a balanced budget to parish council.
- 5. With council approval, manage, monitor and report the parish investments with the diocese.
- 6. Manage and report regularly on the cemetery fund, the memorial fund and the rectory fund.
- 7. Manage the parish endowment fund, and liaise as required with the diocese with respect to any endowment funds invested with the Diocese Consolidated Trust Fund.
- 8. Assist as required parish committees who may need advice on money matters or who are requesting expenditures to further their respective programs.
- 9. Select a member from the committee to serve as the chair and appoint a vice-chair to act in the absence of the chair.
- 10. The Treasurer will be a permanent member of the finance committee and also represent the committee as a permanent member of the parish council.
- 11. Other related duties as may be assigned by council.

As the Terms of Reference state the Finance Committee is a watch dog for the Parish Finances and reports directly to Council. The Council makes all decisions as to the Income and Expenditures within the Church and Parish.

Your Committee met twice during 2013 discussing many topics. The first meeting was to discuss the financial implications of Part Time Ministry.

In 2013 the Committee prepared a Budget, for 2013, and presented it to Council, however it was not balanced. The reason for this is that projected Expenditures exceeded projected Income therefore putting the Budget into a Deficit balance. This situation was left with Council as they are the governing body of the Parish and it will be their task to find a solution to balance the Budget.

The Finance Committee is committed to the financial well-being of the Parish. As Chair of this committee, I feel it is important that the Finance Committee is actively involved regarding the financial matters within the parish.

SYNOD 2013 Report for Annual General Meeting

On May 30 to June 1, 2013 the 144th session of Synod for the Diocese of Nova Scotia and Prince Edward Island was held with the 97 parishes of the Diocese attending. Synod was chaired by Bishop Sue Moxley and we were fortunate to have Archbishop Fred Hiltz in attendance part of the time. The theme for this Synod was "Come to the Waters". Hymns, such as "Come to the Well" and analogies, such as our churches are like lakes with people coming to them and/or rivers flowing out into the community, built on this theme. Worship, with Holy Eucharist, prayers and singing, and reflections on the theme of Synod were interspersed throughout the presentations and business of Synod.

There were 20 plus Motions presented, discussed and voted on. Of particular interest was the motion to change clergy representation to Synod. The commentary stated that some parishes have large numbers of clergy attached to them who are entitled to attend Synod. This can give these parishes a disproportionate representation in any Synod votes. The resolution was passed that "of the entitled clergy of a parish no more than two clerics shall attend each Synod, one of whom should be the rector or incumbent." Another resolution, that has been presented at previous Synods, and was discussed again, was whether to permit raffles as a revenue source. This resolution was again defeated.

The various presenters and topics were current, interesting, sometimes interactive and thought provoking. Some of the presentations were: From AST with information on the various programs available there, including "Leadership Mentoring", "Visioning" and "Good Death Worship": Rev. Ryan Sim speaking of Hope-Church Planting Ministry: Bishop Cutler presenting on the Care to Screen, Parish Abuse, Prevention and Response program: Rev. Lisa Vaughn and the Healthy Church Handbook as well as Reimagining Church, to mention a few.

Again, it was a privilege to attend Synod with the opportunity to learn more about how our church functions, and all the efforts being made to move forward in these changing times.

ELECTORAL SYNOD 2013 Report for Annual General Meeting

On Nov. 22, 2013 an Electoral Synod was held to elect a coadjutor Bishop to succeed The Right Reverend Susan Moxley when she retires Mar. 31. 2014. Those eligible to vote were current clergy and Synod representatives from the Diocese.

Held at the Cathedral Church of All Saints, registration and the presenting of badges and ballots were followed by a Service of Holy Communion. Clergy, who were given red ballots, were to sit on one side of the Cathedral while lay delegates were given blue ballots and sat on the other side.

Information on four candidates was available prior to the Synod. Those offering themselves were: The Right Reverend Ron Cutler, Suffragan Bishop; Rev. Carl Fraser from Sydney, NS; Rev. Peter Wall from Hamilton, ON; and Canon Gary Thorne, Diocesan University Chaplain. On one vote, Rev. Ron Cutler was elected as the Coadjuter Bishop.

The decision of whether there will be an assistant (Suffragan) Bishop is under study by Diocesan Council. We were informed that the 2014 budget was already set and provision made for a Suffragan Bishop. If the decision is that an assistant for the new Bishop is necessary, interested clergy will put their names forward and another election will take place.
