Rector's Report 2021

Well it has been another challenging year, for the second year in a row. In many ways it may seem like St. Andrew's ground to a halt. Periods of no in person worship. Almost (but not quite!) no community events, fundraisers, or socials. Doing our best in all circumstances, conscious of protection, protocols, diocesan directives, and the province. Most committees unable to meet, or meet only during lulls in the pandemic.

As strange as it may sound though, St. Andrew's has indeed been engaged in a lot! While seeming quiet and cautious on the outside, behind the scenes volunteers have taken care of more ministries and responsibilities than normal. To that end, the rest of this report is about saying thank you to people who, if anything, have taken on many extra duties to see us through.

I am thankful for Ken & Rick who have extended their time as wardens in such difficult times. And to the executive committee meeting, consulting and making decisions on just about every aspect of parish life. That extends into the work of parish council who brought flexibility, adaptability and wisdom to doing things in new ways, whether meeting in person, or communicating via mass emails, calls and texts to stay on top of it all. And to some, like our wardens, treasurer and the help of volunteers with special skill sets, there was a great deal of work and ministry that had to be done more independently with less support than is the norm. The Altar Guild, the Ladies Group, the Property & Cemetery committees, the Pastoral Committee for all their calls, visits and care. The finance committee and treasurer overseeing everything financial. And the Ways & Means committee who actually took on two major community events in a year when doing so was very challenging (the take out turkey supper, and the children's Christmas shopping day). Many, many thanks to Tom, Bev and helping hands!

There was even a special group, the Future Group, who met to discuss many excellent ideas we can engage in for parish vitality and ministry, as we emerge from this pandemic.

I also bring a deep gratitude out of 2021 and into 2022 for our worship team. How many weeks in the last two years have that very small group created worship, music and a community of virtual attendees for us? Patti & Sharron continued doing special solos, duets, preludes and

hymns beautifully. Gordon, with far more video savvy than the rest of us, recorded, uploaded to YouTube, and directed our efforts without fail. Marilyn took on more worship services and videos this year than ever (even though retired!) and was a partner in teamwork always.

I am thankful for so much. And yet have not even touched on those who work behind the scenes, organizing, producing bulletins, being sides-persons, helping with funeral logistics, keeping up to date constantly on provincial and diocesan protocols, maintaining and so often updating our website, handling communications it really is a long, long list and I haven't mentioned everything or everyone who kept us safe and operating this year.

There are two very special mentioned I want to raise up this year. They are the Rev'd Marilyn, and Wendy Wells. Rev'd Marilyn retired in 2021 but it hardly seemed so! It was a very demanding year for the ministry of our beloved deacon. Marilyn is embracing retirement again, and in deep gratitude for her years of ministry, and in respect for her many gifts, I pray 2022 will be much more true to the calling to retire. Wendy Wells also has been in the process of retiring, due to illness. It is not easy for someone involved in almost every aspect of parish life for so many years, to be unable to continue carrying on those many responsibilities. And as each position or aspect of parish work was handed on to others, it was crystal clear just how vital Wendy's work for St. Andrews has been, for so long! We miss your skills, wisdom and gifts Wendy. Very, very much.

Our ministries in 2021 have shown us that beneath the many limitations and restrictions of a pandemic, we are so blessed by many people taking care of one another. So blessed!!

We had to revert back to video services.

It was a pleasure this year to make presentations to Parish members Doreen Boutilier, Weldon and Emily Rhyno and Wendy Wells with Certificates of Appreciation for the many years they have faithfully served St. Andrews Church.

PARISH VISION: At our October meeting Council approved that a committee be formed to bring forth the future of the Parish of St. Andrews. Some ideas discussed included what we can do to attract a younger generation. We have Scouts, Guides and Brownies, can we include them in one of our Services? These are just some of the ideas that were discussed.

We only had three in house Council meetings this year and the rest of the year we held Executive meetings with protocol allowing proper spacing in the Church hall. At times it was not necessary to hold in house meetings so we communicated through the electronic network. As Wardens we regularly used email if necessary to resolve any Parish concerns.

The virtual Services will continue for some time guided by Rev. Mark, Rev. Marilyn and the music supplied by organist Patti and solo voice Sharron and finally Gordon for suppling his expertise in doing the video production. Finance Committee Annual Report 2021

The committee of 2021 was comprised of Warden Ken Richardson, Warden and Chair Rick Orlando, Treasurer Keith Fraser, Linda Strachan and Rev Mark Pretty.

For the second year in a row, all quarterly meetings were cancelled due to the Corona Virus Pandemic. Financial matters were handled by the Council who met infrequently in the parish hall, where it was possible to follow all the Covid restrictions. With restricted church gatherings, few fundraising activities and little activity of any kind, the Finance Committee was not tasked with any financial decisions that could not be entertained by Council.

The Treasurer's Report includes all the key financial activity for the year 2021. The main points of interest that make 2021 the second unique year in our parish history include the pandemic financial subsidies from government and the diocese. Revenue was down as were donations, and had it not been for the Covid-19 financial assistance from the Diocese and Federal Government, we would have continued with the pattern of disbursements exceeding revenues. Our investment income was relatively healthy, as the markets remained strong for most of the year, as they also did in 2020.

The long-term prognosis remains the same, and that is that a decision will eventually be needed to either draw down on our investment capital or revert to part time ministry, or some combination of all the cost cutting measures.

Everyone is hopeful that 2022 will bring an easing of restrictions, accompanied by some measure of return to normalcy in the battle against Covid.

Property Committee Report for 2021

On behalf of St. Andrew's Church Property Committee, I am pleased to report the following:

Work done in 2021

On 23rd March, and with funding help from Councillor Iona Stoddard, we had Ryan's Electrical & Security Services install a new security system in St. Andrew's Church. The new system comprises three new keypads, a new control panel, new door closure contacts, two new motion sensors, and new wiring. In addition to the front door and basement door each having an entry keypad (as before) there is now an entry keypad by the door at the top of the ramp.

Part of the stone retaining wall along east side of church was rebuilt after a truck had accidentally pulled some of it down.

Several new graves were opened and closed during the year, and others were maintained as necessary.

This year, the grass was mowed and trimmed by Edmonds Landscaping through from early summer to late fall – thanks to Jack Fleming who paid for this work. A letter was written to Jack to thank him for his generosity.

Several tree limbs were trimmed along the southern edge of the parking lot to improve visibility when emerging onto the highway.

The Hall was rented to Elections NS in August and to Elections Canada in September.

The electrical ballast was replaced in the main fluorescent light fixture in the Furnace Room and a new, larger fluorescent light fixture was installed over the fridge area in the Furnace Room.

The storage cupboard outside the smaller washroom in the basement was re-hung after it had come away from the wall.

The repair of the kitchen dishwasher is being overseen and we are currently awaiting the special parts.

Storage shelving was added to the tool room under the back stairs – primarily for the new Scout Group.

The lighting system for the main outdoor signboard has been completely overhauled with new components fitted as necessary. In addition, Tom has assumed the maintenance of the sign messages.

Property Committee members assisted the Ladies Group with Christmas decorations (inside and outside).

Work planned for 2022

There are no major projects planned for this coming year.

Contact is also made by email and mail and includes Get Well, Thinking of You and Sympathy cards. Birthday cards are sent to those known to be 90 years and older. In addition, visits are made to those at home, in hospital and in nursing homes. Due to COVID many of these activities were curtailed.

In 2021 the Pastoral Care Committee made 256 phone calls, 83 visits, sent 58 cards and 48 emails.

We thank the members of the Pastoral Care Committee for their diligence and dedication to ministering to the Pastoral needs of our parishioners during 2021.
